This is the Second Renewal of the Agreement (hereinafter referred to as "Agreement") made and entered into by and between: BROWARD COUNTY, a political subdivision of the state of Florida (hereinafter referred to as "COUNTY,"), and COMPBENEFITS COMPANY (hereinafter referred to as "COMPBENEFITS"), a Florida corporation authorized to do business in the state of Florida, its successors and assignees.

WHEREAS, the Parties entered into an Agreement on December 6, 2005, for Group Vision Insurance Benefits for Broward County Employees for the contract period from January 1, 2006, through December 31, 2008; and

WHEREAS, the Parties entered into a First Renewal of the Agreement on September 29, 2008 for the contract period from January 1, 2009, through December 31, 2009; and

WHEREAS, pursuant to Article 3 of the Agreement, there remains one (1) additional one-year renewal period available. The Parties wish to renew the Agreement under the same terms and conditions with the modifications noted herein for an additional two-year renewal period.

IN CONSIDERATION of the mutual terms and conditions, promises and covenants hereinafter set forth, COUNTY and COMPBENEFITS agree as follows:

1. The truth and accuracy of each "Whereas" clause set forth above are acknowledged by the Parties and the recitals contained in the "Whereas" clauses are incorporated herein.

2. The Parties hereby renew and readopt the Agreement as amended herein, and retitle same as the "Second Renewal Agreement." Said renewal and readoption shall take effect on January 1, 2010, and terminate on December 31, 2011. All references to a contract period within the Agreement shall now read "January 1, 2010 – December 31, 2011."

3. Article 3, Term of Agreement, is hereby revised to read as follows:

This Agreement shall commence on January 1, 2010, and terminate on December 31, 2011. Notwithstanding the above, COUNTY may, by and through its Contract Administrator and at his/her sole discretion, extend the term of this Agreement on a month to month basis, for a maximum of three (3) months, to allow time for transition to a new vendor.

4. The Exhibit Portion of the Index is hereby revised to read as follows:

EXHIBITS:

- A-2 Certificate of Coverage
- B-2 Premium Rates
- C-2 Performance Standards
- D-2 Certificate of Liability Insurance

5. Article 5, Premiums, Section 5.2 is hereby revised to read as follows:

5.2 COMPBENEFITS agrees that the premium rates set forth in Exhibit "B-2" are guaranteed maximum rates for contract year beginning January 1, 2010 and ending December 31, 2011.

6. Exhibits "A-1," "B-1," "C-1," and "D-1," together with all references thereto, are hereby deleted and replaced with Exhibits "A-2," "B-2," "C-2," and "D-2," attached hereto and incorporated herein.

7. All other terms and conditions of the Agreement not inconsistent herewith shall remain in full force and effect and are to be performed at the levels specified in the Agreement.

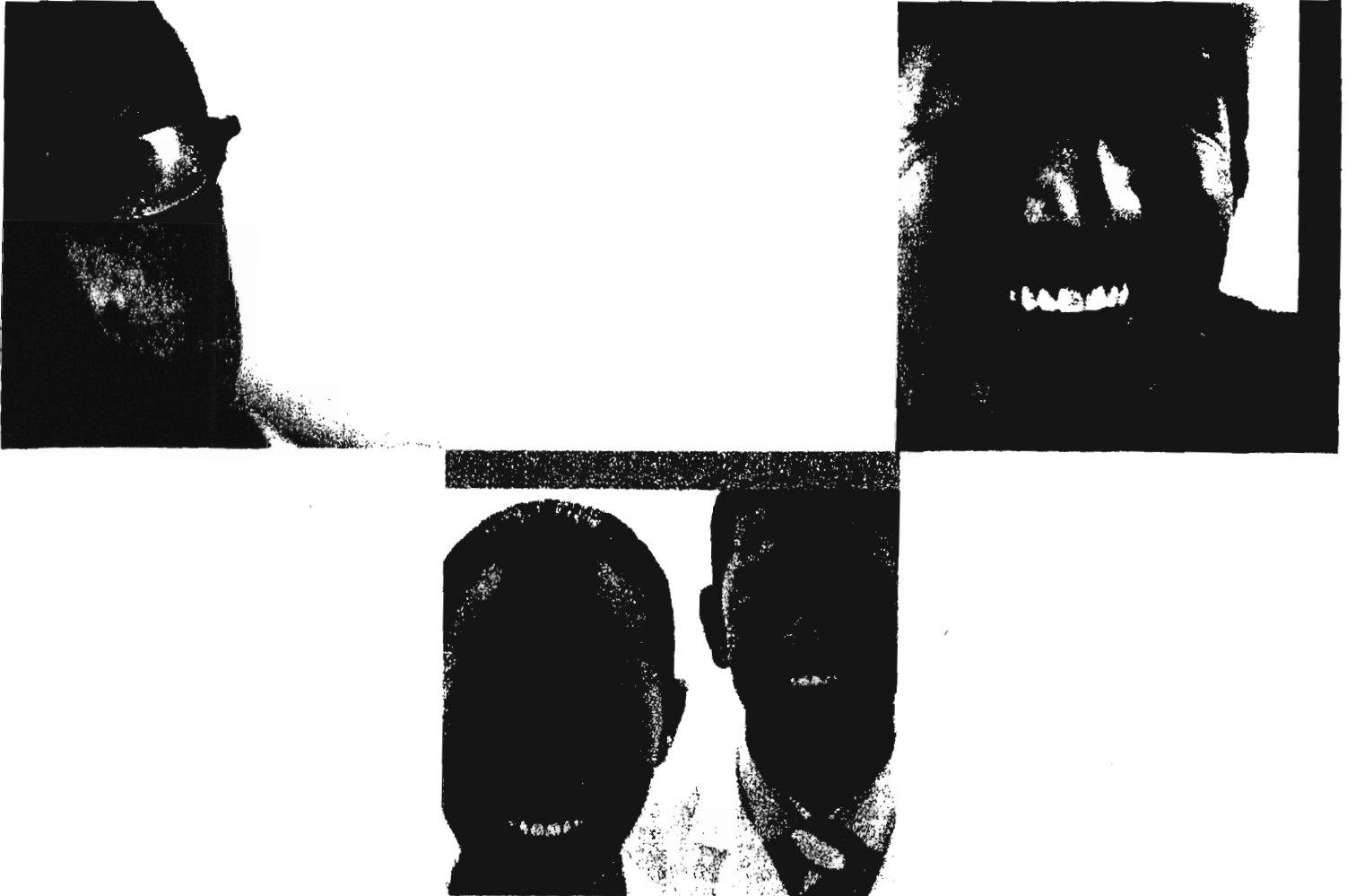

### *Can I get contacts instead of glasses?*

Yes, if you prefer contact lenses, the plan provides an allowance of \$100.00 in place of all other benefits.

The Contact lens Allowance replaces all other benefits for the year. You can select either the Contact Lens Allowance or other covered services (eye glass exam and glasses), but not both.

Twenty percent discounts are available for 12 months after the covered eye exam from the VisionCare Network Provider who performs the initial exam and provides eye glasses or contacts.

This allowance is paid with the same frequency as lenses, in place of all other benefits.

Medically necessary (prior authorization required) is defined as 1) following cataract surgery w/o intraocular lens; 2) correction of extreme visual acuity problems not correctable with glasses; 3) anisometropia greater than 5.00 diopters and asthenopia or diplopia, with spectacles; 4) Keratoconus; or 5) monocular aphakia and/or binocular aphakia where the doctor certifies contact lenses are medically necessary for safety and rehabilitation to a productive life.

\*\*\*Plan members must first contact CompBenefits for a list of providers and to receive a Refractive Care ID card.

## Exhibit C-2

### General Provisions/Service Standards CompBenefits Group Vision Broward County Sub-Group Only

1. Pre-Enrollment Service Standards:
  - a) Enrollment Meetings: COUNTY will schedule annual open enrollment benefit information sessions at various locations and times. COUNTY will provide COMPBENEFITS with a complete list of locations and time at least two (2) weeks prior to the commencement of the first enrollment briefing. COUNTY requires that at a minimum two (2) representatives participate in every information session requested by COUNTY to explain benefits and plan information. Representatives must have excellent knowledge of the COUNTY's benefits and plan information.
  - b) Pre-Enrollment Employee Information Packages and Mailers: COMPBENEFITS will provide and seek approval from COUNTY, in advance of printing, for all materials to be used in the information packages as well as for any and all mailers. At a minimum, packages must include the most recent provider directory, benefit summary, and exclusions and limitations.
  - c) Delivery of Information Packages: COMPBENEFITS will deliver to COUNTY said information packages in a quantity sufficient to distribute to all benefit eligible employees, retirees, COBRA, and survivor participants. The amount to be ordered will be provided by COUNTY to COMPBENEFITS during the material approval process.
  - d) Administrative Fee: COMPBENEFITS agrees to pay an administrative fee to COUNTY as compensation for processing and delivering information packages to all benefit eligible employees, retirees, COBRA and survivor participants. The amount of the fee will be based on a formula that takes the first class cost of one package and multiplying that cost by the number of benefit eligible participants described above. COUNTY will invoice COMPBENEFITS for this administrative fee after distribution. COMPBENEFITS agrees to remit payment within 30 days after invoice date.
  - e) New Plan Year Member ID Card and Welcome Package: COMPBENEFITS agrees to mail all enrolled members a Member ID Card and Welcome Package no later than ten (10) business days after January 1<sup>st</sup> of each plan year. COUNTY agrees to provide COMPBENEFITS with an electronic enrollment list no later than December 31<sup>st</sup> of each year. COUNTY will permit COMPBENEFITS to mail the Member ID Card separate from the Welcome Package.
2. Satisfaction Survey: COMPBENEFITS, in cooperation with other COUNTY healthcare providers, shall procure the services of a third-party administrator to administer the mailing and develop report results for a Member Satisfaction Survey to all enrolled members by September 1<sup>st</sup> of each plan year. The survey tool will be mutually agreed upon by COUNTY and all participating healthcare providers and be mailed by first class United States mail. The proportionate cost of this survey project will be borne by the

participating providers. The proportionate cost of the survey project will be determined based on each provider's own membership share. The resulting report developed by the Third Party Administrator will be delivered to COUNTY no later than December 15 of each plan year and at the same time COMPBENEFITS agrees to provide COUNTY with a corrective action plan addressing any area of the survey that was reported with less than satisfactory service.

3. Provider Directory Stock: COMPBENEFITS agrees to maintain a stock of no less than fifty (50) current provider directories at the offices of Employee Benefits. The maintained stock must be updated no less than on a quarterly basis. COMPBENEFITS further agrees that if a member calls and requests an updated directory, COMPBENEFITS will mail, by first class mail, to that member's home an updated directory within three (3) days.
4. Quarterly Newsletter: COMPBENEFITS agrees to send a quarterly newsletter, by the deadlines specified in Section 1.3 of the Service Agreement. Availability is defined by COMPBENEFITS mailing, by first class mail, to all members, a quarterly newsletter and providing a website with participating provider directory information and noticing members of the website availability by inclusion of such language in the quarterly newsletter.
5. Threatening Letter Response: Should a Member notify COUNTY that he/she has received a letter from a provider threatening legal action, referral to a collection agency, or other negative action which could jeopardize the credit standing of that member because of COMPBENEFITS' delay or failure in paying claims for which COMPBENEFITS is responsible, COUNTY will notify COMPBENEFITS, in writing, of such complaint. In turn, COMPBENEFITS shall respond, in writing, directly to the provider and member, within five (5) days of receipt of such notice from COUNTY, with an explanation of the claim status and initiate a corrective action plan to resolve the issue and assist with removal of any such negative action that may impact a Member's credit. COMPBENEFITS shall also notify COUNTY, to the extent allowable by HIPAA, that action was taken in accordance with this performance standard.
6. ACCOUNT SERVICING: COMPBENEFITS agrees to provide an account manager for the group contract who will visit the COUNTY's Employee Benefits Section per a mutually agreed upon schedule.
7. Administrative Manual: COMPBENEFITS agrees to provide five (5) copies of an administrative manual by December 31<sup>st</sup> of each plan year.
8. Retiree Eligibility: COMPBENEFITS agrees to provide its program to any COUNTY employee upon retirement and continuation thereafter as long as the retiree meets the agreed upon residency requirements and all other plan eligibility requirements.
9. Sub-groups: COMPBENEFITS agrees to include in the COUNTY's employee group, employees of any COUNTY-related public agency which the Board has approved for participation in the COUNTY's group health insurance plans. Sub-groups shall be provided with the same core plan design and premiums afforded the COUNTY. However, all participating sub-groups shall be responsible for payment of their own

premiums as well as being responsible for entering into their own contractual relationships with COMPBENEFITS; and shall negotiate and pay for any other benefits or services they desire beyond the core contract COUNTY has purchased and negotiated, i.e., retiree and COBRA administration, survivor benefit, report generation, etc.

10. Quarterly Reports: COMPBENEFITS will provide quarterly reports on the topics listed below. Such reports are due within forty-five (45) days of the end of the calendar month in which the quarter ends. The reports will be based on Broward county participants broken out by Sub-group, Active, Retiree, Dependents, COBRA, and Survivor, where possible.

TOPICS

Customer Service call response and abandonment  
Network access showing availability of open providers  
Network stability showing percentage of turnovers  
Complaint based on the number and types of complaints filed  
Premium vs. Claims

11. Extension of Service Deadlines: COMPBENEFITS may request an extension of any service standard deadlines established. Such request shall be submitted to the Contract Administrator no less than five (5) business days before the deadline, unless the need for an extension could not reasonably be foreseen by COMPBENEFITS, or is for a reason beyond COMPBENEFITS' control, as determined by the COUNTY. If the request for an extension is based upon extenuating circumstances or other causes beyond COMPBENEFITS control, as determined by COUNTY, approval of the request shall not be unreasonably withheld. COMPBENEFITS' written request must identify the reasons why the established deadline could not be met. The COUNTY may approve the extension request for such period as the COUNTY deems appropriate. COUNTY shall notify COMPBENEFITS of its decision in writing within three (3) business days after receipt of COMPBENEFITS' extension request. Penalties shall not be applied against COMPBENEFITS for failure to meet a specific service standard deadline during the approved extension period. If COMPBENEFITS fails to comply with the specified service standard within the approved extension period, COUNTY may assess the applicable service standard penalty from original date of missed deadline. The COUNTY may grant additional extension periods, as COUNTY deems appropriate, without waiving any of its rights under this Agreement if COMPBENEFITS has commenced curing its non-compliance with the applicable service standard and has exercised good faith during the first extension period.
12. Performance Guarantees: COMPBENEFITS agrees to implement and perform the following performance guarantees within the specified time frames:

Except with respect to damages arising out of a "wrongful act," any person or entity designated on a certificate of insurance issued by or on behalf of the Named Insured as an additional insured, but only to the extent of such designation and only with respect to liability of the additional insured arising out of operations of the Named Insured. Coverage is not provided under this policy for the acts or omissions of such person or entity or the acts or omissions of its employees, agents or representatives.
