

RESOLUTION NO. 2009-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AUTHORIZING THE ACCEPTANCE OF A DONATION IN THE AMOUNT OF TEN THOUSAND DOLLARS (\$10,000.00) FROM THE FRIENDS OF THE PERCY WHITE LIBRARY, INC., FOR ADULT AND CHILDREN'S BOOKS FOR THE USE AND BENEFIT OF THE BROWARD COUNTY DEERFIELD BEACH PERCY WHITE BRANCH; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE ACTIONS; PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Friends of the Percy White Library, Inc. has most generously offered to donate Ten Thousand Dollars (\$10,000.00) for the purchase of adult and children's books, for the use and benefit of the Broward County Deerfield Beach Percy White Branch Library; and

WHEREAS, Section 18.63 of the Broward County Administrative Code provides for the acceptance and acknowledgement by the Board of County Commissioners of Broward County of donations to the County that are valued at Five Hundred Dollars (\$500.00) or more; and

WHEREAS, the Board of County Commissioners of Broward County wishes to accept the generous gift, and to express its gratitude for such donation; NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

1 Section 1. The Board of County Commissioners of Broward County, Florida,
2 hereby accepts the donation in the amount of Ten Thousand Dollars (\$10,000.00), from
3 Friends of the Percy White Library, Inc. whose local address is 837 E. Hillsboro
4 Boulevard, Deerfield Beach, FL 33441, for the purchase of adult and children's books
5 for the use and benefit of the Broward County Deerfield Beach Percy White Branch
6 Library.

7 Section 2. The County Administrator is hereby authorized to take all
8 administrative actions necessary to implement this matter.

9 Section 3. SEVERABILITY.

10 If any portion of this Resolution is determined by any Court to be invalid, the
11 invalid portion shall be stricken, and such striking shall not affect the validity of the
12 remainder of this Resolution. If any Court determines that this Resolution, or any
13 portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies),
14 property(ies), or circumstance(s), such determination shall not affect the applicability
15 hereof to any other individual, group, entity, property, or circumstance.

16 Section 4. EFFECTIVE DATE.

17 This Resolution shall become effective upon its adoption.
