The Office of Economic and Small Business Development concurs with the Purchasing Division's recommendation to reject Chealsey Corporation because the firm is not certified to provide the products solicited; Atlantic Coast Distributors, Inc. and Namco of Broward, Inc. because they have been deemed non-responsive since they did not respond to the bid specifications; and award the bid to Arm Electrical Services as the low responsive SBE-certified firm in the certification type: Commodities/Construction Services.
