

1 RESOLUTION DIRECTING THE COUNTY ADMINISTRATOR TO
2 PUBLISH NOTICE OF PUBLIC HEARING TO CONSIDER ADOPTION
3 OF A RESOLUTION AMENDING THE ADMINISTRATIVE CODE

4 BE IT RESOLVED by the Board of County Commissioners of Broward County,
5 Florida, that:

6 Section 1. The County Administrator in and for Broward County, Florida, and
7 Ex-Officio Clerk of the Board of County Commissioners of Broward County is authorized
8 and directed to publish notice of intent of the Board of County Commissioners of
9 Broward County to consider at public hearing on Tuesday, September 14, 2010, at 2:00
10 p.m., the adoption of a resolution amending the Administrative Code, to be entitled:

21 SECTION 41.01, "FIXED-ROUTE, DIRECTLY OPERATED
22 BUS FARE STRUCTURE"; BY REPEALING SECTION
23 41.02, "THIRTY-ONE DAY BUS PASS PRICES CHARGED
24 TO COUNTY EMPLOYEES" BY REPEALING SECTION
41.04, "PARATRANSIT FARE STRUCTURE" BY
ENACTING A NEW SECTION 41.01, "FIXED-ROUTE,
DIRECTLY OPERATED BUS FARE STRUCTURE," TO
INCREASE FARES AS SET FORTH IN THE REVISED
FARE SCHEDULE; BY ENACTING A NEW SECTION
41.02, "THIRTY-ONE DAY BUS PASS PRICES CHARGED
TO BROWARD COUNTY EMPLOYEES," TO INCREASE
FARES AS SET FORTH IN THE REVISED FARE
SCHEDULE; BY ENACTING A NEW SECTION 41.04,
"PARATRANSIT FARE STRUCTURE," TO INCREASE
FARES AS SET FORTH IN THE REVISED PARATRANSIT

1 FARE SCHEDULE; PROVIDING FOR SEVERABILITY;
2 PROVIDING FOR INCLUSION IN THE BROWARD
3 COUNTY ADMINISTRATIVE CODE; AND PROVIDING
4 FOR AN EFFECTIVE DATE."

5 Section 2. Such notice shall be made pursuant to the applicable provisions of
6 Section 3.04 of the Broward County Charter; provided, however, that at least one Notice
7 of Intent to hold a public meeting must be published in a newspaper of general
8 circulation in Broward County, not less than ten (10) days prior to the date of the public
9 hearing, as required by MTF-18, Requirement for Public Hearing.

10 Section 3. This Resolution shall take effect upon adoption.
