13 41.02, "THIRTY-ONE DAY BUS PASS PRICES CHARGED
14 TO COUNTY EMPLOYEES" BY REPEALING SECTION

PROVIDING FOR INCLUSION IN THE BROWARD
COUNTY ADMINISTRATIVE CODE; AND PROVIDING
FOR AN EFFECTIVE DATE.

17 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF

19 Section 1. The title of Chapter 41 "Fees and Other Charges, Office of
20 Transportation" shall be amended to read as follows:

23 Structure," is hereby repealed in its entirety and a new Section 41.01, "Fixed-Route,

For Disabled and Medicare fare, proof of disability (valid Medicare card) and photo identification are required. For College Student Bus Pass, a valid dated college identification card or a copy of current college course schedule shall be required at the time of purchase of the College Student Bus Pass. When utilizing a College Student Bus Pass, a photo identification and college student identification card shall be presented upon boarding a bus. Eligible patrons are encouraged to acquire a Broward County Transit (BCT) Reduced Fare photo identification card.
