A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, DIRECTING THE COUNTY ADMINISTRATOR TO PUBLISH A NOTICE OF PUBLIC HEARING TO BE HELD ON TUESDAY, SEPTEMBER 14, 2010, AT 2:00 P.M., IN ROOM 422, BROWARD COUNTY GOVERNMENTAL CENTER, FOR THE PURPOSE OF RECEIVING PUBLIC INPUT ON PROPOSED CHANGES TO THE BROWARD COUNTY TRANSIT DIVISION'S FIXED-ROUTE BUS SERVICE INCLUDING: PROPOSED WEEKDAY SERVICE REDUCTIONS ON ROUTES 4, 7, 9, 10, 11, 14, 16, 22, 28, 30, 31, 48, 50, 60, 81, AND 83; PROPOSED WEEKEND SERVICE REDUCTIONS ON ROUTES 2, 4, 5, 6, 7, 9, 10, 11, 14, 16, 20, 22, 28, 30, 31, 40, 42, 48, 50, 81, 83, AND 88; PROPOSED ELIMINATION OF ROUTES 3, 15, 17, 23, 56, AND 57; PROPOSED SERVICE CHANGES AND REALIGNMENT OF ROUTES 36 AND 81; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. The County Administrator, in and for Broward County, Florida, and Ex-Officio Clerk of the Board of County Commissioners of said County, is authorized and directed to publish a notice of intent of the Board of County Commissioners of Broward County to hold a Public Hearing on Tuesday, September 14, 2010, at 2:00 p.m., for the purpose of receiving public input on the proposed changes to the Broward County Transit Division's fixed-route bus service including: the proposed weekday service reductions on routes 4, 7, 9, 10, 11, 14, 16, 22, 28, 30, 31, 48, 50, 60, 81, and 83; the proposed weekend service reductions on routes 2, 4, 5, 6, 7, 9, 10, 11, 14, 16, 20, 22, 28, 30, 31, 40, 42, 48, 50, 81, 83, and 88; the proposed elimination of routes 3,

1 15, 17, 23, 56, and 57 and the proposed service changes and realignments of routes 36
2 and 81.

4 Section 2. Such notice shall be made not less than ten (10) days prior to the
5 date of the public hearing as required by MTF-18, Requirement for Public Hearing.

6 Section 2. EFFECTIVE DATE.

7 This Resolution shall take effect upon adoption; provided, however, the fixed -
8 route bus eliminations and service reductions shall take effect on October 31, 2010.
