3 A RESOLUTION OF THE BOARD OF COUNTY
4 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
5 AMENDING CHAPTER 37, PART IV, OF THE BROWARD
6 COUNTY ADMINISTRATIVE CODE; PROVIDING A
7 REVISED PARK SYSTEM FEE SCHEDULE
8 COMMENCING FY 2011; PROVIDING FOR
SEVERABILITY; PROVIDING FOR INCLUSION IN THE
BROWARD COUNTY ADMINISTRATIVE CODE; AND
PROVIDING FOR AN EFFECTIVE DATE.

9 WHEREAS, it is the desire of the Broward County Board of County
10 Commissioners to amend Chapter 37, Part IV, of the Broward County Administrative
11 Code relating to Broward County Park System Fee Schedule commencing FY 2011;
12 and

13 WHEREAS, the revised fee schedule commencing FY 2011 is reasonable and
14 necessary; NOW, THEREFORE,

15 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
16 BROWARD COUNTY, FLORIDA:

17 Section 1. That the Board of County Commissioners of Broward County, Florida,
18 hereby amends Volume III, Chapter 37, Part IV, of the Broward County Administrative
19 Code, as provided for herein and adopts and institutes the amended fee schedule
20 commencing FY 2011 as set forth in Exhibit "A," attached hereto and incorporated
21 herein.

22 Section 2. SEVERABILITY.

23 If any portion of this Resolution is determined by any Court to be invalid, the
24 invalid portion shall be stricken, and such striking shall not affect the validity of the

1 remainder of this Resolution. If any Court determines that this Resolution, or any
2 portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies),
3 property(ies), or circumstance(s), such determination shall not affect the applicability
4 hereof to any other individual, group, entity, property, or circumstance.

5 Section 3. INCLUSION IN ADMINISTRATIVE CODE. It is the intention of the
6 Board of County Commissioners that the provisions of this Resolution shall become and
7 be made a part of the Broward County Administrative Code; and that the sections of this
8 Resolution may be renumbered or relettered and the word "resolution" may be changed
9 to "section," "article," or such other appropriate word or phrase in order to accomplish
10 such intentions.

11 Section 4. EFFECTIVE DATE.

12 This Resolution shall become effective October 1, 2010.

PART IV. BROWARD COUNTY PARK SYSTEM FEE SCHEDULE

37.32. General.

The Board of County Commissioners of Broward County, Florida, adopts and institutes the following amended fee schedule set forth below for the Broward County Parks and Recreation Division commencing FY 20102011. Programs sponsored or co-sponsored by the Broward County Parks and Recreation Division are exempt from the payment of fees set forth in this fee schedule. Programs sponsored by non-profit organizations (registered with the State of Florida or designated as an Internal Revenue Code Section 501(c)(3) corporation), other governmental entities, and private entities are required to pay the fees set forth in this fee schedule.
