RESOLUTION DIRECTING THE COUNTY ADMINISTRATOR TO PUBLISH NOTICE OF PUBLIC HEARING TO CONSIDER THE ADOPTION OF A RESOLUTION AMENDING THE ADMINISTRATIVE CODE

Section 1. The County Administrator in and for Broward County, Florida, and Ex-Officio Clerk of the Board of County Commissioners of said county is authorized and directed to publish notice of intent of the Broward County, Board of County Commissioners, to consider at the public hearing on Tuesday, September 14, 2010, at 2:00 p.m., the adoption of a resolution amending the Administrative Code, to be entitled:
