

1 RESOLUTION DIRECTING THE COUNTY ADMINISTRATOR
2 TO PUBLISH NOTICE OF PUBLIC HEARING TO CONSIDER
3 ENACTMENT OF AN ORDINANCE

4 BE IT RESOLVED by the Board of County Commissioners of Broward County,
5 Florida, that:

6 Section 1. The County Administrator in and for Broward County, Florida, and
7 Ex-Officio Clerk of the Board of County Commissioners of Broward County is authorized
8 and directed to publish notice of intent of the Board of County Commissioners of
9 Broward County to consider at public hearing on Tuesday, September 14, 2010, at
10 2:00 p.m., the enactment of an ordinance to be entitled:

18 AMENDMENTS TO THE AMERICANS WITH DISABILITIES
19 ACT OF 1990; CHANGING THE DEFINITION OF
20 "EMPLOYER" IN SUBSECTION 16 $\frac{1}{2}$ -3(s) TO ONE THAT
21 EMPLOYS FIVE (5) OR MORE EMPLOYEES; PROVIDING
22 IN SUBSECTION 16 $\frac{1}{2}$ -30.6(c) FOR REDETERMINATION
23 REVIEWS BY A SINGLE HUMAN RIGHTS BOARD
24 MEMBER IN DUAL-FILED CASES; EDITING TERMS AND
PHRASES IN SECTIONS 16 $\frac{1}{2}$ -30.7, 16 $\frac{1}{2}$ -52, 16 $\frac{1}{2}$ -63,
16 $\frac{1}{2}$ -64.2, 16 $\frac{1}{2}$ -66, AND 16 $\frac{1}{2}$ -67; PROVIDING FOR
SEVERABILITY; PROVIDING FOR INCLUSION IN THE
CODE; AND PROVIDING FOR AN EFFECTIVE DATE."
