 Section 1. The above recitals are true and correct and are incorporated herein as if set forth in full hereunder.

- Section 2. The Board allocates Fiscal Year 2013/2014 SHIP Program funding in the amount of One Hundred Sixty Thousand Dollars (\$160,000.00) as provided in Attachment "1," attached hereto and made a part hereof.
- Section 3. The County Administrator is authorized to take all necessary administrative action for implementation of the SHIP Program.
- Section 4. The County Administrator is authorized to execute agreements allocating the SHIP Program funds, as provided for in this Resolution, in forms approved by the Office of the County Attorney, which shall include all standard agreement provisions, and incorporate recommendations from Broward County's Risk Manager or County Auditor, so long as the recommendations are in the best interest of the County and do not change the approved project amounts.
- Section 5. The County Administrator is authorized to execute amendments to extend the term of an agreement or modify the project consistent with Section 420.907, Florida Statutes, and all applicable SHIP Program rules and regulations.

Section 6. SEVERABILITY.

If any portion of this Resolution is determined by any Court to be invalid, the invalid portion shall be stricken, and such striking shall not affect the validity of the remainder of this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies), property(ies), or circumstance(s), such determination shall not affect the applicability hereof to any other individual, group, entity, property, or circumstance.
