PURPOSE: Through Contract 34305, BARC provides community-based substance abuse services including medically supervised residential detoxification, intensive residential treatment, non-residential day treatment and outpatient counseling to Broward County residents' age 18 years and older. This Third Contract Amendment provides additional funds for the expansion of substance abuse services to pregnant and post-partum women and their affected families under FY2013-14 State of Florida Specific Appropriation 375. These services shall include the expansion of residential treatment, outpatient treatment with housing support, and post-partum case management supporting both the mother and child. The amendment increases the award by \$190,000 and the match requirement by \$18,802.
