

RESOLUTION NO. 2014-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, ACCEPTING A DONATION FROM SEVEN (7) LIBRARY SUPPORT GROUPS TOTALING FIVE THOUSAND EIGHT HUNDRED TWENTY-ONE DOLLARS (\$5,821), TO BE DEPOSITED INTO THE BROWARD COUNTY LIBRARY TRUST FUND FOR THE USE AND BENEFIT OF THE LIBRARIES DIVISION IN SUPPORT OF LIBRARY STAFF CONFERENCE TRAVEL; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND BUDGETARY ACTIONS REQUIRED TO IMPLEMENT SAME; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, seven (7) Library support groups have most generously offered to donate to the County amounts totaling Five Thousand Eight Hundred Twenty-one Dollars (\$5,821) for deposit into the Broward County Library Trust Fund for the use and benefit of the Broward County Libraries Division to support Library employee conference travel to the annual Florida Library Association Conference that will be held in Lake Buena Vista, Florida, from May 7 through 9, 2014; and

WHEREAS, Section 18.63 of the Broward County Administrative Code provides for the acceptance and acknowledgement by the Board of County Commissioners of Broward County, Florida ("Board"), of donations valued at Five Hundred Dollars (\$500) or more; and

WHEREAS, the Board wishes to accept the generous gift and to express its gratitude for such donation, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

1       Section 1.   The Board hereby accepts the donation of Five Thousand Eight  
2 Hundred Twenty-one Dollars (\$5,821) from seven (7) Library support groups listed on  
3 Attachment 1, attached hereto, for deposit into the Broward County Library Trust Fund,  
4 for the use and benefit of the Broward County Libraries Division to support Library  
5 employee conference travel to the Annual Florida Library Association Conference that  
6 will be held in Lake Buena Vista, Florida, from May 7 through 9, 2014.

7       Section 2.   The County Administrator is hereby authorized to take all  
8 administrative and budgetary actions required to implement acceptance of the donation  
9 in this matter.

10       Section 3.   SEVERABILITY.

11       If any portion of this Resolution is determined by any Court to be invalid, the  
12 invalid portion shall be stricken, and such striking shall not affect the validity of the  
13 remainder of this Resolution. If any Court determines that this Resolution, or any  
14 portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies),  
15 property(ies), or circumstance(s), such determination shall not affect the applicability  
16 hereof to any other individual, group, entity, property, or circumstance.

17       Section 4.   EFFECTIVE DATE.

18       This Resolution shall become effective upon adoption.
