FIRST AMENDMENT TO INTERLOCAL AGREEMENT

THIS FIRST AMENDMENT TO INTERLOCAL AGREEMENT ("Amendment") made this ______ of _____, 2014, by Broward County, a political subdivision of the State of Florida, hereinafter referred to as "County", the City of Parkland, a municipal corporation existing under the laws of the State of Florida, hereinafter referred to as "City", Kenneth N. Drake, Linda G. Drake, Danny D. Cagle, Patrick Stanley, the Vannelli family, Ltd, Their successors and/or assigns (collectively, "Owners"). And Standard Pacific of Florida, a Florida general partnership ("Standard Pacific"):

WITNESSETH:

WHEREAS, the County, City, Owners and Standard Pacific entered into that certain Interlocal Agreement recorded on December 16, 2013 in Book 50408 Page 226 of the Public Records of Broward County, Florida ("Agreement"). All terms not otherwise defined herein shall have the same meaning as set forth in the Agreement; and

WHEREAS, pursuant to the terms of the Agreement, 101 dwelling units were permitted to be constructed on the Property and the parties agree to amend the Agreement to reflect that the Owners seek to develop 131 dwelling units on the Property.

NOW, THEREFORE, in consideration of the foregoing premises and the promises and covenants herein contained, the parties hereby amend the Agreement as follows.

- 1. The recitals set forth above are true and correct and are incorporated into this Amendment by this reference.
- 2. The Agreement as amended by this Amendment remains in full force and effect except as specifically amended herein. To the extent of any inconsistency between the terms of this Amendment and the terms of the Agreement, the terms of this Amendment shall supersede and control to the extent of such inconsistency. This Amendment shall be interpreted in a manner which is consistent with and gives full effect to the complete Agreement.
 - 3. All strikethrough text in this Amendment shall indicate deletion of language from

the Agreement and all underlined text in this Amendment shall indicate new language in the Agreement.

- 4. Section 1.6 of the Agreement is hereby amended as follows:
- The Broward County Land Use Plan Map is the effective land use plan map for 1.6 the Property and the other areas of the Wedge that have not been annexed into the City of Parkland. The Broward County Land Use Plan Map designates the Property as Palm Beach County Rural Residential 10 which permits residential uses not to exceed 1 dwelling unit per 10 acres. Four (4) dwelling units are permitted on the Property based on the existing land use designation. The land use plan description on the land adjacent to the Property owned by Standard Pacific described on Exhibit "B" ("Adjacent Lands") is Residential (2) which allows a total of 600 dwelling units on the Adjacent Lands. Standard Pacific was granted site plan and plat approval for 458 dwelling units on the Adjacent Lands and 142 available dwelling units remain. Upon acquiring the Property, Standard Pacific proposes to utilize 97 127 of the available dwelling units from the Adjacent Lands in addition to the four (4) dwelling units permitted on the Property to develop a total of 101 131 dwelling units on the Property. City and County acknowledge that a land use plan amendment is not required to obtain City and County approvals to develop 101 131 dwelling units on the Property upon approval by the City and County of a document ensuring unified development such as a unified master plan.
- 5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together will constitute one and the same instrument.
