MUTUAL TERMINATION OF INTERLOCAL AGREEMENT FOR THE ACQUISITION, IMPROVEMENT, ENHANCEMENT, OPERATION, AND MANAGEMENT OF OPEN SPACE SITE OS-145 MIDDLE RIVER TERRACE PARK ADDITION

THIS MUTUAL TERMINATION is entered into by and between: BROWARD COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "COUNTY" and CITY OF FORT LAUDERDALE, a Florida municipal corporation created and existing under the laws of the State of Florida, hereinafter referred to as "CITY."

WHEREAS, on October 14, 2008, COUNTY and CITY entered into that Interlocal Agreement for the Acquisition, Improvement, Enhancement, Operation, and Management of Open Space Site OS-145 Middle River Terrace Park Addition, hereinafter referred to as "Agreement"; and

WHEREAS, the Agreement provided for CITY's acquisition of Open Space Site OS-145 ("Property") with proceeds from the 2000 Broward County Safe Parks and Land Preservation Bond Issue; and

WHEREAS, the stated purpose of the Agreement was to provide funding for the acquisition and for the subsequent improvement and operation of the Property consistent with the terms of the Bond Issue; and

WHEREAS, CITY executed a Contract on September 5, 2007 with Dominick Casale and Vincen. Fazio ("Sellers") for the purchase of the Property; and

WHEREAS, initial environmental testing was performed pursuant to the Contract which revealed the presence of unacceptable levels of arsenic in both the soil and groundwater with the Contract specifying the Sellers' responsibility to remediate the arsenic contamination as a condition precedent to closing the Property; and

WHEREAS, Sellers failed to perform remediation of the contamination in accordance with the terms of the Contract; and

WHEREAS, the Sellers no longer hold title to the Property, having lost same through foreclosure, and, as a consequence the CITY no longer has a valid Contract for the purchase of the Property; and

WHEREAS, based on the Sellers nonperformance under the Contract and the fact that there is no longer a binding Contract for the CITY's purchase of the Property, the parties are desirous of terminating the Agreement;

IN CONSIDERATION of the foregoing and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The above recitals and representations are true and correct and are incorporated herein.
- The parties hereby agree that the Agreement is hereby terminated and each agrees to release the other from all rights, obligations, and duties under the Agreement.
- 3. This Mutual Termination shall be effective upon execution by the COUNTY.
