BE IT RESOLVED by the Board of County Commissioners of Broward County, Florida, that:

Section 1. The County Administrator in and for Broward County, Florida, and Ex-Officio Clerk of the Board of County Commissioners of Broward County is authorized and directed to publish notice of intent of the Board of County Commissioners of Broward County to consider at public hearing, on June 10, 2014, the adoption of a resolution amending the Administrative Code, to be entitled:

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO RATES, FEES AND CHARGES AT THE FORT LAUDERDALE-HOLLYWOOD INTERNATIONAL AIRPORT, AMENDING CHAPTER 39 OF THE BROWARD COUNTY ADMINISTRATIVE CODE; AMENDING SECTION 39.2, "RATES, FEES AND CHARGES - FORT LAUDERDALE-HOLLYWOOD INTERNATIONAL AIRPORT," TO REFLECT CHANGES TO THE AIRLINE PASSENGER SERVICE INCENTIVE PROGRAMS SECTION; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE BROWARD COUNTY ADMINISTRATIVE CODE, AND PROVIDING FOR AN EFFECTIVE DATE.

Section 2. Such notice shall be made pursuant to the applicable provisions of Chapter 2, Article 1, Section 2-3 of the Broward County Code of Ordinances and Section 3.04, of the Broward County Charter.

Section 3. This Resolution shall take effect on upon adoption.
