

RESOLUTION NO. 2014 -

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO ANIMAL CARE; AMENDING SECTION 40.38 OF THE BROWARD COUNTY ADMINISTRATIVE CODE; "ANIMAL CARE AND ADOPTION FEE SCHEDULE"; PROVIDING FOR A BREEDER FEE AND PENALTY; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE BROWARD COUNTY ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Chapter 40, "Fees and Other Charges, Environmental Protection and Growth Management Department," Part VI, "Permitting, Licensing, and Consumer Protection Division," Section 40.38, is hereby amended to read as follows:

**40.38. Animal Care and Adoption Section Fee Schedule.**

The following fee schedule is hereby adopted:

I. *Permit Fees*

1. Guard Dog Owner .....	200.00
2. Guard Dog Service .....	1,000.00
<u>3. Breeder</u> .....	<u>100.00</u>

n. *Civil Penalties.* Any person cited for an infraction of Chapter 4 shall pay a civil penalty for each infraction. Offenses are determined by the owner's name, not animal's name.

<u>21. Failure to Obtain a Breeder Permit (4-6.5)</u> .....	<u>50.00</u>

2 Section 2. SEVERABILITY.

3 If any portion of this Resolution is determined by any Court to be invalid, the  
4 invalid portion shall be stricken, and such striking shall not affect the validity of the  
5 remainder of this Resolution. If any Court determines that this Resolution, or any  
6 portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies),  
7 property(ies), or circumstance(s), such determination shall not affect the applicability  
8 hereof to any other individual, group, entity, property, or circumstance.

9 Section 3. INCLUSION IN THE ADMINISTRATIVE CODE.

10 It is the intention of the Board of County Commissioners that the provisions of  
11 this Resolution shall become and be made a part of the Broward County Administrative  
12 Code; and that the sections of this Resolution be renumbered or relettered and the word  
13 "resolution" may be changed to "section," "article," or such other appropriate word or  
14 phrase in order to accomplish such intentions.

15 Section 4. EFFECTIVE DATE.

16 This Resolution shall become effective upon adoption.
