

RESOLUTION NO. 2014-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, ACCEPTING DONATIONS OF ELECTRONIC SNAP CIRCUITS EXTREME KITS TO SUPPORT SCIENCE, TECHNOLOGY, ENGINEERING, AND MATHEMATICS PROGRAMMING AT THE BROWARD COUNTY NORTH REGIONAL/BROWARD COLLEGE LIBRARY AND THE BROWARD COUNTY NORTHWEST REGIONAL LIBRARY, VALUED AT OVER FIVE HUNDRED DOLLARS (\$500), FROM FRIENDS OF THE NORTH REGIONAL/BC LIBRARY, INC., AND NORTHWEST REGIONAL FRIENDS OF THE LIBRARY, INC.; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND BUDGETARY ACTIONS; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, Friends of the North Regional/BC Library, Inc., and Northwest Regional Friends of the Library, Inc., have each offered to donate twenty-four (24) Electronic Snap Circuits Extreme Kits to support the Science, Technology, Engineering, and Mathematics ("STEM") programs at the Broward County North Regional/Broward College Library and the Broward County Northwest Regional Library; and

WHEREAS, Section 18.63 of the Broward County Administrative Code provides for the acceptance and acknowledgement by the Board of County Commissioners of Broward County, Florida ("Board"), of donations to the County that are valued at Five Hundred Dollars (\$500) or more; and

WHEREAS, the Board wishes to accept the generous gift, and to express its gratitude for such donation, NOW, THEREFORE,

1 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
2 BROWARD COUNTY, FLORIDA:

4 Section 1. The Board of County Commissioners of Broward County, Florida,  
5 hereby accepts two (2) donations, each consisting of twenty-four (24) Electronic Snap  
6 Circuits Extreme Kits to support the STEM programs at the Broward County North  
7 Regional/Broward College Library and the Broward County Northwest Regional Library,  
8 valued at over Five Hundred Dollars (\$500), from Friends of the North Regional/BC  
9 Library, Inc., whose local address is 1100 Coconut Creek Boulevard, Coconut Creek,  
10 Florida 33066, and Northwest Regional Friends of the Library, Inc., whose local  
11 address is 3151 University Drive, Coral Springs, Florida 33065.

12 Section 2. The County Administrator is hereby authorized to take all  
13 administrative and budgetary actions and execute all forms required to implement  
14 acceptance of the donation in this matter.

15 Section 3. SEVERABILITY.

16 If any portion of this Resolution is determined by any Court to be invalid, the  
17 invalid portion shall be stricken, and such striking shall not affect the validity of the  
18 remainder of this Resolution. If any Court determines that this Resolution, or any  
19 portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies),  
20 property(ies), or circumstance(s), such determination shall not affect the applicability  
21 hereof to any other individual, group, entity, property, or circumstance.

1       Section 4.   EFFECTIVE DATE.

2       This Resolution shall become effective upon adoption.
