RESOLUTION NO. 2014-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO THE DIVERSITY ADVISORY COUNCIL; AMENDING SECTION 12.91 OF THE BROWARD COUNTY ADMINISTRATIVE CODE TO MODIFY THE NUMBER OF MEMBERS OF THE DIVERSITY ADVISORY COUNCIL; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE BROWARD COUNTY ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Broward County, Florida, has determined that amending Section 12.91 of the Administrative Code, decreasing the number of members of the Broward County Diversity Advisory Council, is appropriate at this time, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Chapter 12, Part VIII, of the Broward County Administrative Code is hereby amended as follows:

PART VIII. BROWARD COUNTY DIVERSITY ADVISORY COUNCIL

...

12.91. Appointments, Membership, and Organization.

a. The Broward County Diversity Advisory Council shall consist of ~~eighteen~~ nine (18 9) members. Each member of the ~~Broward Board of County Commissioners~~ shall appoint ~~two~~ one (2 1) members whose term of office shall be as set forth in

1 Section 1-233 of the Broward County Code of Ordinances, ~~as may be amended from~~
2 ~~time to time.~~

3 b. The Human Services Department shall provide all reasonable
4 administrative and clerical assistance desired by the Broward County Diversity Advisory
5 Council.

6 c. The Broward County Diversity Advisory Council shall adopt rules, bylaws,
7 or such other regulations as it deems desirable for the efficient conduct and discharge
8 of its duties and functions.

10 Section 2. CONFORMING OF RESOLUTIONS.

11 All resolutions or parts of resolutions that are inconsistent or in conflict with this
12 Resolution are hereby deemed to be conformed to this Resolution, to the extent
13 necessary to resolve the inconsistency or conflict.

14 Section 3. SEVERABILITY.

15 If any portion of this Resolution is determined by any Court to be invalid, the
16 invalid portion shall be stricken, and such striking shall not affect the validity of the
17 remainder of this Resolution. If any Court determines that this Resolution, or any
18 portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies),
19 property(ies), or circumstance(s), such determination shall not affect the applicability
20 hereof to any other individual, group, entity, property, or circumstance.

21 Section 4. INCLUSION IN THE ADMINISTRATIVE CODE.

22 It is the intention of the Board of County Commissioners that the provisions of this
23 Resolution shall become and be made a part of the Broward County Administrative
24 Code; and that the sections of this Resolution be renumbered or relettered and the word
