3	A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4	GRANTING A NON-EXCLUSIVE RESTRICTED CARGO HANDLER FRANCHISE TO FAST TERMINAL CORP TO
5	PROVIDE CARGO HANDLER SERVICES AT PORT EVERGLADES, RESTRICTED TO PROPRIETARY CARGO
6	HANDLED ON VESSELS OWNED OR CHARTERED BY SC LINE, S.A. AND CARGO THAT IS "NEW BUSINESS"
7	AS DEFINED BY SECTION 32.16.b.10 OF THE BROWARD COUNTY ADMINISTRATIVE CODE; PROVIDING FOR A
8	ONE-YEAR TERM AT PORT EVERGLADES; PROVIDING FOR NON-DISCRIMINATION/APPLICABLE LAW;
9	PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.
10	AN EFFECTIVE DATE.
11	WHEREAS, the Broward County Board of County Commissioners (the "Board")
12	adopted Resolution 94-1302 creating Chapter 32 of the Broward County Administrative
13	Code, effective November 22, 1994, to provide for the regulation of businesses
14	requiring franchises to conduct operations at Port Everglades; and
15	WHEREAS, Fast Terminal Corp, has submitted an application for a non-
16	exclusive restricted cargo handler franchise and the Board has relied on the
17	representations of Fast Terminal Corp, and reviewed the application in light of the
18	requirements of Chapter 32 of the Broward County Administrative Code as amended;
19	and
20	WHEREAS, the public hearing required for this franchise was conducted on April
21	22, 2014; and
22	WHEREAS, based on representations of Fast Terminal Corp, and information
23	presented by County staff and the public, the Board does hereby find, determine and
24	

declare the non-exclusive restricted franchise to be in the public interest; NOW,
 THEREFORE,

3 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
4 BROWARD COUNTY, FLORIDA:

5 Section 1. The foregoing "WHEREAS" clauses are true and correct and
6 hereby ratified by the Board of County Commissioners.

7 Section 2. <u>AWARD OF RESTRICTED FRANCHISE TO FAST TERMINAL</u>
 8 <u>CORP</u>

9 Fast Terminal Corp, is hereby granted a non-exclusive restricted franchise to
10 provide cargo handler services at Port Everglades. The non-exclusive restricted
11 franchise extends only to cargo handler services for proprietary cargo handled on
12 vessels owned or chartered by SC Line, S.A. and cargo that is "New Business" as
13 defined in Section 32.16.b.10 of the Broward County Administrative Code.

14 Section 3. <u>TERM.</u>

The non-exclusive restricted franchise shall be for a period of one (1) year,
commencing April 22, 2014, and ending on April 21, 2015, unless sooner terminated in
accordance with the provisions of the franchise including, Broward County
Administrative Code, Chapter 32, Section 32.29 as amended.

Section 4. NON-DISCRIMINATION/APPLICABLE LAW.

By accepting this non-exclusive restricted franchise, Fast Terminal Corp, agrees
that its effectiveness is subject to strict compliance with Broward County Human Rights
Act (Broward County Code, Chapter 16-1/2), all rules, regulations and ordinances,
including the Broward County Administrative Code and Code of Ordinances, now or

hereafter promulgated by Broward County with respect to the conduct of the business
operated pursuant to this franchise and is also subject to the terms and provisions of all
federal and state laws, as amended from time to time, affecting the conduct of the
business for which Fast Terminal Corp, is hereby franchised. The imposition and
enforcement of such laws to which this franchise shall be subject, shall operate
uniformly with respect to all persons, firms, or corporations holding similar franchises
within Port Everglades.

Section 5. <u>SEVERABILITY.</u>

9 If any portion of this Resolution is determined by any Court to be invalid, the 10 invalid portion shall be stricken, and such striking shall not affect the validity of the 11 remainder of this Resolution. If any Court determines that this Resolution, or any portion 12 hereof, cannot be legally applied to any individual(s), group(s), entity(ies), property(ies), 13 or circumstance(s), such determination shall not affect the applicability hereof to any 14 other individual, group, entity, property, or circumstance.

Section 6. EFFECTIVE DATE.
