2 A RESOLUTION OF THE BOARD OF COUNTY  
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,  
4 ACCEPTING A DONATION OF A SHELVING SYSTEM,  
5 VALUED AT FIVE HUNDRED DOLLARS (\$500) OR MORE,  
6 FROM FRIENDS OF THE DAVIE/COOPER CITY LIBRARY,  
7 INC., FOR THE USE AND BENEFIT OF BROWARD  
8 COUNTY'S DAVIE/COOPER CITY BRANCH LIBRARY IN  
9 THE BOOK FAIR AREA; AUTHORIZING THE COUNTY  
10 ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND  
11 BUDGETARY ACTIONS TO IMPLEMENT ACCEPTANCE;  
12 AND PROVIDING FOR SEVERABILITY AND AN  
13 EFFECTIVE DATE.

14 WHEREAS, Friends of the Davie/Cooper City Library, Inc., has most generously  
15 offered to donate a shelving system, valued at Five Hundred Dollars (\$500) or more, for  
16 the use and benefit of Broward County's Davie/Cooper City Branch Library which will  
17 provide three sets of new shelving in the Book Fair area; and

18 WHEREAS, Section 18.63 of the Broward County Administrative Code provides  
19 for the acceptance and acknowledgement by the Board of County Commissioners of  
20 Broward County, Florida ("Board"), of donations to the County that are valued at Five  
21 Hundred Dollars (\$500) or more; and

22 WHEREAS, the Board wishes to accept the generous gift and to express its  
23 gratitude for such donation, NOW, THEREFORE,

24 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
BROWARD COUNTY, FLORIDA:

Section 1. The Board hereby accepts the donation of a shelving system,  
valued at Five Hundred Dollars (\$500) or more, from Friends of the Davie/Cooper City

1 Library, Inc., whose address is 4600 S.W. 82 Avenue, Davie, Florida 33328, to provide  
2 three new sets of shelving in the Book Fair area of Broward County's Davie/Cooper City  
3 Branch Library.

4 Section 2. The County Administrator is hereby authorized to take all  
5 administrative and budgetary actions and execute all forms required to implement  
6 acceptance of the donation in this matter.

7 Section 3. SEVERABILITY.

8 If any portion of this Resolution is determined by any Court to be invalid, the  
9 invalid portion shall be stricken, and such striking shall not affect the validity of the  
10 remainder of this Resolution. If any Court determines that this Resolution, or any  
11 portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies),  
12 property(ies), or circumstance(s), such determination shall not affect the applicability  
13 hereof to any other individual, group, entity, property, or circumstance.

14 Section 4. EFFECTIVE DATE.

15 This Resolution shall become effective upon adoption.
