JUSTIFICATION:

Assistant Director of Environmental and Consumer Protection: The new classification will be responsible for assisting with planning and managing the day-to-day operations. The added layer of divisional management is needed due to the nature of the work and level of supervision required to oversee environmental and consumer protection programs.

Director of Environmental Engineering and Permitting: The new classification will be responsible for managing the use, storage, and disposal of solid waste to protect the environment and health, safety, and welfare of the people of Broward County, to identify and abate contaminated sites; to support Department efforts in resource protection, enforcement, and compliance; to administer the water engineering and licensing regulatory program, the aquatic and wetland resources regulatory program, the tree preservation and abuse regulatory program, and to minimize exposure of the public in Broward County to air pollution and airborne nuisances through programs designed to inform the public and to control emissions from stationary, mobile, and indoor sources.
