With the league expected to get underway in the first week of August, Guardian Media understands that talks are in progress with a potential buyer from India but nothing

is concrete just yet. CPL has been pumping money into the product since the inception in 2014 and is yet to turn around a profit.

What they have done though is create a product that is now a viable one and a sale at this point in time could fetch them a handsome amount, to offset the funds they would have pumped into the league.

Only last year, all six teams were picked up by owners and prior to this CPL had to bankroll the teams that had no owners. This cost a handsome amount and with regional governments not coming on board as before because of the current economic climate in the Caribbean, the business model has been struggling.

Cheif Executive Officer (CEO) Damian O'donohue said that last year would have been a profitable one for the CPL but it was not. He mentioned prior to last year's tournament that CPL had already invested US\$20 million.

He added that even in the long term a realistic profit will be two to three million a year.

With the help of Indian investment the CPL has moved on from humble beginnings, when the marquee sponsors besides Digicel were an electronics store called Courts and a skin tonic called Limacol. The tournament has now attracted much juicier endorsement from Hero Motocorp, the world's largest manufacturer of motorcycles.

That the 2015 trophy was lifted by the Trinidad & Tobago Red Steel was convenient for organisers as that franchise was recently acquired by the owners (Bollywood star Shah Rukh Khan among them) of Kolkata Knight Riders, one of the IPL sides that is as yet unaffected by the current corruption saga hampering that league.

Zouks New Owner In Trouble

Just about a week since there was a lavish announcement of the purchase of the Zouks franchise of the Hero Caribbean Premier League (CPL), grey clouds appear ready to dump some rain on that party.

Last week, the CPL was all over itself as it been purchased by Mr.

Jignesh 'Jay' Pandya of Royal Sports Club, based in Philadelphia.

By last weekend, there was a deafening silence when news broke, according to St. Luca Online News, that Pandya, "is currently facing charges of fraud and operating a ponzi scheme in the US."

The charge of fraud was, according to St. Lucia Online News, brought to the US courts by plaintiff Jagdish Patel against Pandya and another co-accused.

Further information that has come to hand, said that the legal issue stemmed from an alleged financial fraud that has elements of a ponzi scheme.

Pandya is said to be the founder of the Rohan Group of companies, 'a real estate venture with over 100 combined commercial and retail properties that employs in excess of 1,200 people'.

In welcoming the purchase of Zouks, Mr. Damien O'Donohoe, CEO of the Hero CPL, said then: "Today is a landmark day for the Zouks franchise, and indeed for the Hero CPL, and is further evidence of the growing stature of the biggest party in sport both in the Caribbean and internationally.'

It appears that the Hero CPL was attracted to Pandya because of his recent (September 29) acquisition of exclusive licensing rights for a Franchised T20 Professional Cricket League, by the United States of America Cricket Association.

There has been, up to press time Wednesday, no reaction to this recent development by the Hero CPL administration.

ACTION: (T-12:34 PM) Following Board discussion, the Board directed staff to draft a proposal to provide terms of an agreement as a sole source contract and to also draft a proposal based on waiving the procurement code. (Refer to minutes for full discussion.)

VOTE: 9-0.

Why Action is Necessary

Action would authorize the County Administrator to take all necessary administrative actions required to implement an agreement between Worldwide Sports Management and Broward County.

What Action Accomplishes

An agreement between Worldwide Sports to have a minimum of three multi-day international cricket tournament matches annually in Broward County beginning in 2017 and for a license to program these events in the Broward County Central Regional Park.

Is this Action Goal Related

Summary Explanation/Background

Broward County Central Regional Park's principle feature is a championship cricket stadium built to international specifications. Having regularly scheduled international cricket events will require significant marketing and business development resources. Worldwide Sports Management Group (Worldwide) is offering to market cricket tournaments to bring in international teams and leagues to Broward County. Examples are World T20 Championship featuring championship teams from Pakistan Super League (PSL), Caribbean Premier League (CPL), and Bangladesh Premier League (BPL). Worldwide commits to placing a priority on local vendors and CBE businesses and will make sure those vendors are timely paid. Worldwide will coordinate with Broward County to utilize vendors from approved vendor lists. Worldwide has submitted a proposal and draft agreement for the County's consideration (Exhibit Nos. 1 and 2).



Promotion and Management for International Cricket Matches at Broward County's Central Broward Regional Park

History:

Broward County (County), through its Parks and Recreation Division, owns and operates Central Broward Regional Park (the "Park"), located in Lauderhill, FL. The Park includes a sports complex, the featured amenity being a multi-purpose, 5,000 seat stadium with covered seating and additional seating for 15,000 spectators. Other stadium amenities include a large, two-story building with large windowed areas for field events viewing, locker rooms, restrooms, and limited, "VIP" seating area. The stadium is designed to host a variety of sporting and other events, and has the field dimensions and pitch to include international cricket tournaments. Currently, this is the only cricket stadium in the United States certified by the International Cricket Council (ICC). The Park also has several covered picnic pavilions of varying sizes, and a number of different athletic fields and courts, plus an aquatic center.

Objective:

The stadium receives many bookings, primarily for soccer training and matches. Presently, the stadium/stadium field is booked for approximately 300 days a year. Although cricket matches have been a smaller portion of the overall stadium bookings, the County would like to increase the number of international cricket matches held at the stadium.

Purpose:

The purpose of the Request for Information (RFI) is to locate vendors that may be interested in becoming the promotion and management firm for international cricket matches at the stadium. This RFI is not a request for pricing or a commitment to contract with your firm; it is only to gather information about potential vendors.

Scope of Work/Responsibilities:

The County would expect a promotion and management firm to secure and schedule multiple, high-quality international cricket matches annually, featuring high-level professional, international teams.

A promotion and management firm would be responsible for any or all of the following:

- a. Negotiating and securing international teams for matches at the Park for single or multiday events. The firm would be responsible for all fees to reach agreements to bring international cricket matches to the stadium.
- b. Paying and/or coordinating the following:
 - i. travel arrangements for the teams and staff;
 - ii. staffing (administrative, operational, and maintenance);
 - iii. ticketing, parking, security, city permits, customer relations, food, beverages, and souvenirs sales for the matches; and
 - iv. post-match clean-up and trash removal.
- c. Promoting matches, through local, national, and international marketing outreach efforts.
- d. Managing the stadium and field maintenance relating to or arising out of the cricket matches
- e. Capital and other improvements needed at the stadium for international cricket events.

The County wishes to ensure that the promotion and management of international cricket matches' harmonizes with the existing theme and quality of stadium and Park operations. The firm would need to work closely with the Park/stadium management to coordinate events' scheduling, logistics, and administrative functions. Additionally, the firm would need to comply with revenue reporting and payments, carrying appropriate insurance and bonding, and other contractual obligations with the County.

The County would not expect to incur costs for cricket matches under this promotion and management relationship. The County would negotiate a fee structure with a promotion and management firm in exchange for international cricket matches at the Park.

Another aspect the County would be interested in, is to have an international cricket team that is a member of an international, professional league, to use the Park as a home stadium. The County already has anchor tenants' relationships at the stadium with an American professional soccer league team and with a training academy for an international professional soccer organization. The County would like to add a third team/organization tenant for international cricket.

Response:

Interested firms should submit their nonbinding letters of introduction, with examples of previous experience (including promoting, operating, and/or coordinating one or more similar types of events at sports venues, such as arenas or stadiums).
