

## OFFICIAL STRUCTURE OF CRICKET BOARDS AROUND THE WORLD

### ICC: International Cricket Council

The ICC is the global governing body for cricket. Representing 105 members, the ICC governs and administrates the games and works with members to grow the sport. The ICC also stages its own events. It presides over the ICC Code of Conduct, playing conditions, the Decision Review System, and other ICC regulations. The ICC also appoints all match officials who officiate at all sanctioned international matches. Through the Anti-Corruption Unit, it coordinates action against corruption and match fixing.

### Full Members of the ICC

The governing bodies for cricket in a country or region recognized by the ICC, or nations associated for cricket purposes, or a geographical area, from which representative teams are qualified to play official test matches (10 members).

1. **BCB**: Bangladesh Cricket Board – governs 21 members in Asia along with BCCI, PCB, and SLC
2. **\*BCCI**: Board of Control for Cricket in India – governs 21 members in Asia along with BCB, PCB, and SLC
3. **CA**: Cricket Australia – governs 11 members in East Asia-Pacific along with NZC
4. **CSA**: Cricket South Africa – governs 22 members within Africa region along with CZ
5. **CZ**: Cricket Zimbabwe – governs 22 members within Africa region along with CSA
6. **EWCB**: England and Wales Cricket Board – governs 33 members in Europe
7. **\*NZC**: New Zealand Cricket – governs 11 members in East Asia-Pacific along with CA
8. **PCB**: Pakistan Cricket Board – governs 21 members in Asia along with BCB, BCCI, and SLC
9. **SLC**: Sri Lanka Cricket – unknown – governs 21 members in Asia along with BCB, BCCI, and PCB
10. **\*WICB**: West Indies Cricket Board – governs 17 members in North America, Central America, and South America, including the Caribbean Premier League
