Subject: Salary for the Interim County Auditor

Attached for your signature is form BC-102 establishing the salary and benefits for the Interim County Auditor, Kathie-Ann Ulett, effective February 4, 2017. The salary and benefits for Kathie are the same as my current salary and benefits. This is consistent with the long standing practice of the Board to provide employees serving as Interim County Attorney or Interim County Administrator the same compensation as the person they replaced (Please see the attached summary of the most recent interim appointments). When the interim appointment ends, the employee returns to their previous position at their previous salary.

From a historical perspective, negotiations of compensation for a newly appointed County Administrator or County Attorney have been delegated by the Board to the Auditor. Following the negotiations, the compensation and terms of employment were submitted to the Board for approval. Salary negotiations for a newly appointed Auditor have been directly between the Board and the Auditor to maintain the independence of the office and avoid any conflicts between the Auditor and future auditees.


