

RESOLUTION NO. 2017-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, ACCEPTING A DONATION FROM THE FRIENDS OF THE STIRLING ROAD BRANCH LIBRARY, INC., THROUGH A GENEROUS CONTRIBUTION FROM BABY K'TAN LLC IN THE AMOUNT OF ONE THOUSAND THREE HUNDRED TEN DOLLARS (\$1,310), TO BE DEPOSITED INTO THE BROWARD COUNTY LIBRARY TRUST FUND; AUTHORIZING EXPENDITURE OF THESE FUNDS TO PURCHASE THREE (3) IPADS FOR CHILDREN USE AT THE BROWARD COUNTY STIRLING ROAD BRANCH LIBRARY; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND BUDGETARY ACTIONS TO IMPLEMENT ACCEPTANCE; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, Friends of the Stirling Road Branch Library, Inc., through a generous contribution from Baby K'tan LLC, has offered to donate to the County the amount of One Thousand Three Hundred Ten Dollars (\$1,310), to purchase three (3) iPads for children use at the Stirling Road Branch Library; and

WHEREAS, Section 18.63 of the Broward County Administrative Code provides for the acceptance and acknowledgement by the Board of County Commissioners of Broward County, Florida ("Board"), of donations to the County that are valued at Five Hundred Dollars (\$500) or more; and

WHEREAS, Section 19.32 of the Broward County Code of Ordinances requires Board approval of expenditures from the Broward County Library Trust Fund; and

WHEREAS, the Board wishes to accept the generous gift, and to express its gratitude for such donation, NOW, THEREFORE,

1 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
2 BROWARD COUNTY, FLORIDA:

4 Section 1. The Board hereby accepts the donation of One Thousand Three  
5 Hundred Ten Dollars (\$1,310) from the Friends of the Stirling Road Branch Library, Inc.,  
6 located at 3151 Stirling Road, Hollywood, Florida 33312. The amount of \$1,310 will be  
7 deposited into the Broward County Library Trust Fund.

9 Section 2. The Board hereby authorizes the expenditure of these funds to  
10 purchase three (3) iPads for children use at the Stirling Road Branch Library.

12 Section 3. The County Administrator is hereby authorized to take all  
13 administrative and budgetary actions and execute all forms required to implement  
14 acceptance of the donation and expenditure of the funds in this matter.

16 Section 4. SEVERABILITY.

17 If any portion of this Resolution is determined by any Court to be invalid, the invalid  
18 portion shall be stricken, and such striking shall not affect the validity of the remainder of  
19 this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot  
20 be legally applied to any individual(s), group(s), entity(ies), property(ies), or  
21 circumstance(s), such determination shall not affect the applicability hereof to any other  
22 individual, group, entity, property, or circumstance.
