WHEREAS, TRIP provides funds to improve regionally significant transportation

WHEREAS, FDOT has approved an amount of Two Million Eight Hundred Twentyeight Thousand Two Hundred Forty-nine Dollars (\$2,828,249) for Fiscal Year 2017-2018 TRIP capital funds for the purchase of eight (8) high capacity passenger express buses;

WHEREAS, Broward County is required to match the FDOT funding; and

WHEREAS, a TRIP grant agreement must be approved by the Board of County Commissioners of Broward County, Florida, NOW, THEREFORE,

The Board of County Commissioners of Broward County, Florida, 5 ("Board") authorizes its Mayor to execute a TRIP grant agreement with FDOT, District 4, in 6 substantially the form attached as Exhibit 1, in the amount of Two Million Eight Hundred 7 Twenty-eight Thousand Two Hundred Forty-nine Dollars (\$2,828,249), granted under Financial Management No. 436418-1-94-01, to provide funding for the purchase of eight (8) 8 high capacity passenger express buses, which, along with Broward County's matching funds, totals Five Million Six Hundred Fifty-six Thousand Four Hundred Ninety-eight Dollars 10 11 (\$5,656,498).12 Section 2.
