RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF **BROWARD** COUNTY FLORIDA. **AUTHORIZING** THE **MAYOR** TO EXECUTE SUPPLEMENTAL JOINT PARTICIPATION AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT), DISTRICT 4, TO PROVIDE ADDITIONAL FUNDING ÓF ONE MILLION SEVEN HUNDRED AMOUNT FORTY-EIGHT THOUSAND THREE HUNDRED NINETY-TWO (\$1.748.392) FOR THE INTERSTATE 95 (I-95) DOLLARS EXPRESS BUS SERVICE AND TO INCLUDE FDOT AS THE LIEN HOLDER FOR CAPITAL PURCHASES ASSOCIATED WITH OPERATING THE I-95 EXPRESS BUS SERVICE; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE **NECESSARY ADMINISTRATIVE** AND BUDGETARY ACTIONS: AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 341.041, Florida Statutes, the Florida Department of Transportation ("FDOT") provides technical and financial assistance for intercity bus service; and

WHEREAS, on December 1, 2016, Broward County and FDOT entered into a Joint Participation Agreement ("JPA") in the amount of Two Million Eight Hundred Forty-three Thousand Two Hundred Six Dollars (\$2,843,206) for Fiscal Year 2016-2017 capital funding for the Interstate 95 Express Bus Service; and

WHEREAS, FDOT has authorized One Million Seven Hundred Forty-eight Thousand Three Hundred Ninety-two Dollars (\$1,748,392) in additional FY 2017-2018 funding to supplement the Two Million Eight Hundred Forty-three Thousand Two Hundred Six Dollars (\$2,843,206) previously granted under Financial Project Number

 423393-2-94-01 for a total of Four Million Five Hundred Ninety-one Thousand Five Hundred Ninety-eight Dollars (\$4,591,598) in funding for the project; and

WHEREAS, FDOT has required Broward County include a provision in the Supplemental Joint Participation Agreement ("SJPA") which requires FDOT to be listed as the lien holder for any capital purchases in which FDOT contributes fifty percent (50%) or more to the actual purchase price; and

WHEREAS, the SJPA must be approved by the Board of County Commissioners of Broward County, Florida, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. The Board of County Commissioners of Broward County, Florida (Board), hereby approves and authorizes the Mayor to execute an SJPA with FDOT, District 4, in substantially the form attached as Exhibit 1, in the amount of One Million Seven Hundred Forty-eight Thousand Three Hundred Ninety-two Dollars (\$1,748,392) in additional funding granted under Financial Project No. 423393-2-94-01, to provide capital funding for the Interstate 95 (I-95) Express Bus Service, which requires FDOT to be listed as the lien holder for any capital purchases, associated with operating the I-95 Express Bus Service, for which FDOT contributes fifty percent (50%) or more to the actual purchase price.

Section 2. The Board authorizes the County Administrator to take all necessary administrative and budgetary actions to implement the SJPA.
