Lorraine,

Per our discussion we will be requesting Board approval of increased funding in the amount of \$31,240 (\$26,240 for full time outreach at Main Library & \$5,000 for additional intensive street outreach as need in county-wide). The planned increase will be effective Jun 1 to September 30, 2017. The hours need at the main library should be relatively consistent with their hours of operation included below:

Main Library:
100 S Andrews Avenue, Fort Lauderdale, FL 33301,
Hours: Monday, Thursday, Friday, Saturday: 10AM-6PM • Tuesday and Wednesday: Noon-8PM • Sunday: Closed

Additionally, we will seek to have County security have a visible presence around the main library and will request increased support from Fort Lauderdale PD Outreach Officers.

We will review the demand and need in the next month as we identify funding levels for FY18.
