I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

Micro Focus software is required to run the County's current Payroll/Human Resources/Position Control system, CYBORG, which has been used for processing Payroll and Human Resources transactions. ETS has licensed the Micro Focus licenses and has gone through several generational upgrades since 1997.

With the delay in the implementation of the PeopleSoft Human Capital Module (HCM) and the desire to run this new module in a parallel mode with CYBORG after its initial implementation, Broward County needs to renew the licensing agreement with Micro Focus in order to continue to use the CYBORG system.

Micro Focus Server for COBOL is only maintained by Micro Focus and is sold via authorized resellers. As the sole owner of the Micro Focus support programs, Micro Focus will only grant their authorized resellers the ability to sell Micro Focus support programs as a commodity.

This will allow Broward County the flexibility it should need to accommodate the current delay in implementation and the desire to run the old and new system in parallel after initial implementation of HCM.

Quotes were received from both the parent organization, Micro Focus, and SHI. The Micro Focus quote was \$89.39 less expensive per year than SHI. Since the Micro Focus quote is less expensive, and since we have been dealing directly with Micro Focus for a number of years, it is recommended that we continue to deal directly with Micro Focus for this extension.
