

## RESOLUTION NO. 2017-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, ACCEPTING A DONATION FROM T-MOBILE WITH AN ESTIMATED VALUE OF SIXTY-ONE THOUSAND TWO HUNDRED NINETY-EIGHT DOLLARS; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND BUDGETARY ACTIONS TO ACCEPT THE DONATION; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, Broward County Libraries has partnered with T-Mobile, Broward Public Schools, and CareerSource Broward, among other entities, to help underprivileged children further their education and improve the employment prospects of unemployed adults who are seeking work and who have a household income of less than Thirty-Six Thousand Two Hundred Seventy-Three Dollars (\$36,273); and

WHEREAS, the initiative will run as a two-year pilot program; and

WHEREAS, pursuant to this initiative, T-Mobile will donate to the County 160 tablets to be loaned to K - 12th grade students who qualify for free or reduced lunches and to qualifying residents seeking employment; and

WHEREAS, T-Mobile will also offer unlimited data at a discounted rate of Ten Dollars (\$10) per month, per tablet, instead of the customary rate of Twenty Dollars (\$20) per month, per tablet; and

WHEREAS, T-Mobile's donation has an estimated value of Sixty-One Thousand Two Hundred Ninety-Eight Dollars (\$61,298); and

WHEREAS, Section 18.63 of the Broward County Administrative Code provides that donations to Broward County of Five Hundred Dollars (\$500) or more shall be

1 accepted by a resolution of the Board of County Commissioners of Broward County,

4 WHEREAS, the Board wishes to accept the donation, NOW, THEREFORE,

6 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
7 BROWARD COUNTY, FLORIDA:

9 Section 1. The Board hereby accepts the donation of 160 tablets and  
10 corresponding data plans from T-Mobile with an estimated value of Sixty-One Thousand  
11 Two Hundred Ninety-Eight Dollars (\$61,298).

13 Section 2. The County Administrator is hereby authorized to take all  
14 administrative and budgetary actions and execute all forms required to accept the  
15 donation.

17 Section 3. SEVERABILITY.

18 If any portion of this Resolution is determined by any Court to be invalid, the  
19 invalid portion shall be stricken, and such striking shall not affect the validity of the  
20 remainder of this Resolution. If any Court determines that this Resolution, or any  
21 portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies),  
22 property(ies), or circumstance(s), such determination shall not affect the applicability  
23 hereof to any other individual, group, entity, property, or circumstance.
