GRANTING RENEWAL OF A NONEXCLUSIVE FRANCHISE 4 TO PORT CONTRACTORS - SOUTHEAST, LLC, FOR A FIVE-YEAR TERM TO PROVIDE STEAMSHIP 5 SERVICES AT PORT EVERGLADES: AND PROVIDING COMPLIANCE NONDISCRIMINATION. 6 APPLICABLE LAW, SEVERABILITY, AND AN EFFECTIVE DATE. 7 8 WHEREAS, the Broward County Board of County Commissioners (the "Board") 9 adopted Resolution No. 94-1302 creating Chapter 32 of the Broward County 10 Administrative Code, effective November 22, 1994, to provide for the regulation of 11 12 businesses requiring franchises to conduct operations at Port Everglades; and 13 WHEREAS, Port Contractors – Southeast, LLC, has submitted an application for 14 a franchise, and the Board has relied on the representations of Port 15 Contractors – Southeast, LLC, and reviewed the application in light of the requirements 16 of Chapter 32 of the Broward County Administrative Code; and WHEREAS, the public hearing required for this franchise was conducted on 17 18 August 22, 2017; and 19 WHEREAS, based on representations of Port Contractors – Southeast, LLC, and 20 information presented by County staff and the public, the Board does hereby find, 21 determine, and declare the franchise to be in the public interest, NOW, THEREFORE, 22 23 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF 24 BROWARD COUNTY, FLORIDA:

The franchise shall be for a period of five (5) years, commencing on August 30, 2017, and ending on August 29, 2022, unless sooner terminated in accordance with the provisions of the franchise, including Section 32.29 of the Broward County Administrative Code.

Section 4. NONDISCRIMINATION/APPLICABLE LAW.

By accepting this nonexclusive franchise, Port Contractors - Southeast, LLC, agrees that the effectiveness of the franchise is subject to strict compliance with the Broward County Human Rights Act (Chapter 16½, Broward County Code of Ordinances), and all rules, regulations, and ordinances, including the Broward County Administrative Code and Code of Ordinances, now or hereafter promulgated by Broward County pertaining to the conduct of the business operated pursuant to this franchise, and is also subject to the terms and provisions of all federal and state laws, as amended from time to time, affecting the conduct of the business for which Port Contractors – Southeast, LLC, is hereby franchised. The imposition and enforcement of such laws to which this franchise shall be subject shall operate uniformly with respect to all persons, firms, or corporations holding similar franchises within Port Everglades.

1 Section 5. SEVERABILITY. 2 If any portion of this Resolution is determined by any Court to be invalid, the invalid 3 portion shall be stricken, and such striking shall not affect the validity of the remainder of this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot 4 5 be legally applied to any individual(s), group(s), entity(ies), property(ies), or 6 circumstance(s), such determination shall not affect the applicability hereof to any other 7 individual, group, entity, property, or circumstance. 8 Section 6.
