I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

Water and Wastewater Operations Division (WWOD) is responsible for the treatment and transmission of wastewater, the treatment and distribution of potable water, and the transmission of raw water for its retail and regional customers in Broward County. To accomplish this effort, the Division operates and maintains water treatment plants and water supply facilities, regional wellfields, a wastewater treatment/reclamation plant, and regional master pumping stations, which are all considered to be critical infrastructure by the U.S. EPA.

These facilities are expected to operate 24/7 and be able to continue operation on FPL supplied power or on emergency generator power, if FPL power is not available. As such, these fourteen facilities contain twenty seven (27) permanent, on-site, diesel-fueled generators, which were manufactured by Caterpillar, to provide electrical power during emergencies or FPL power outages. Please refer to the attached listing of WWOD Caterpillar generator locations and sizes.

WWOD is requesting sole source/sole brand award for this contract to Pantropic Power, Inc. to perform diagnostic testing, parts replacement, and repairs to these Caterpillar generators to ensure 24/7 ready to provide power to these critical facilities without any down time. Pantropic Power, Inc. has been recognized as the authorized dealer for Caterpillar power generator parts and service in 13 Florida counties, including Broward and Dade.
