REQUISITION NO. SOLE SOURCE/SOLE BRAND REQUEST REQUEST: Provide a description of the features of the product/service or Scope of Work. Production Company to operate a large-scale renaissance festival at Quiet Waters Park for seven weekends. The productions company would pay the County a even fees to conduct the event, and the County would not incur any additional expense. II. JUSTIFICATION: Please check all boxes that describe your reason(s) for determining that only one source or brand is reasonably available. Only Sole Source/ Uniqueness Proprietary Item - this vendor/source has the only rights to provide this service or commodity. A letter from the manufacturer or authorizing entity is included in this request. Technology Improvements - updates or upgrades to an existing system, software, software as a service (SaaS), hardware purchases. Engineering Direction - engineering drawing or specification identifies product; "no substitutes or equivalents will be acceptable." Only qualified supplier - reliability and maintainability of the product or service would be degraded unless specified supplier is used; may void warranty. This request includes a copy of the current warranty information. Other/or Additional information - the County requires this sole source, sole brand purchase for the 1 following reasons: The Parks and Recreation Division is requesting Bobby Rodriguez Productions for the Florida Renaissance Festival ("FRF) at Quiet Waters Park to be again considered the only reasonable source. The County has had a series of Agreement with Bobby Rodriquez Productions for 20 years for the FRF. The FRF pays an event fee to the County for the event, and the County does not incur any additional expenses. Bobby Rodríguez Productions owns the rights and name for the FRF. The FRF is about a two month on-site

process at the Park (including set-up and take down) each year, in which the portion of the Park is utilized exclusively for the FRF, its storage area, temporary living area for the FRF "cast"/crew, utility hook up, tec. This is in addition to the year-round planning, business, etc. activities related to the event. From a logistical standpoint, it is an elaborate set-up/breakdown arrangement, requiring close cooperation between the FRF, Park staff, and the County of Deerfield Beach. Through the years County Park staff and FRF representatives have built a fluid working relationship resulting in smoother operations and a comfort level that only comes with experience in working with the other party over a period of times. This is important not because of the longevity of the relationship, but because the public has high expectations for the event, and the County wishes to continue having the event provided at the expected quality level.

Running a large-scale renaissance festival (RF) is a very specialized type of enterprise. While there are a number of RF's throughout the country, as a rule RF's lie to find a region or local home and stay there, enhancing their offerings over time. Fundamentally, there are two types of large RF's stationary, in which a permanent "village" wither permanent buildings, etc. house the RF; and portable, in which the RF sets up its operations for a period of time, then dismantles same. Although the RF technically is portable, in a sense it is also a hybrid arrangement due to the number of sites and infrastructure improvement made in Quiet Waters Park over the years, i.e. installation of power centers and waters supplies in key event locations for permanent utility connections, along with shade structures for festival expansion. The improvements were a collaborative effort between the Park and Bobby Rodriguez Productions for improved accommodations for the FRF and enhanced experience for the public. These modifications accommodate the FRF layout that has evolved over the past 16 years.

The present agreement with Bobby Rodriguez productions runs through April 4, 2016. It is time to begin planning for the next agreement. This is a very popular venture for the public, a revenue producer for the Park, and has been and is agreeable to the County.

Given that, and pursuant to County staff investigation, Bobby Rodriguez Productions is once again the only known local RF production source that is large enough to meet the Broward County RF needs, and retrofitting Quiet Waters Park to specially accommodate this production's needs, and the experience factors by this company in hosting this annual event, the Parks and Recreation Division is interested in seeking a direct contract with this company to continue this relationship between the County and Bobby Rodríguez Productions under terms and conditions negotiated in Sunshine, and approvable by the Board.

The Parks and Recreation Division has done many public/private contracts through the years, both competitively bid and through direct contracts. The Division is a firm believer in opening up projects to the completive marketplace whenever it is required and even when not strictly required when it is in the project's best interest. It is submitted that this is not the case here. While theoretically there may be other RF companies in the U.S. that could provide similar services for the County's RF, Bobby Rodriguez Productions is again the only reasonable source known in Broward County to provide such services at this level because of the reasons previously described, i.e. logistical standpoint, longevity of the relationship related to the high public expectations for the event, and a large scale RF being a very special type of enterprise. Plus, if this project were to be competitively proposed, and placed into Shelter Market, Bobby Rodriguez Productions would be the only available vendor to reasonably supply the desired services. Moreover, the FRF site has been gradually tailored through the years to best accommodate the Park's and Bobby Rodriguez Productions needs for the event to be held fluidly as possible. Change in vendors would result in retrofitting the park to specifically accommodate the new production's needs along with impacting park operations with increased time for set-up and breakdown. Our research indicates that Bay Area Renaissance Festival, Tampa FL: Sarasota Medieval Fair, Sarasota, FL; Riverdale Kiwanis Medieval Faire, Ft. Meyers, FL; Hoggtown Medieval Faire, Gainesville, FL; Gulf Coast Renaissance Faire, Pensacola, FL: and Camelot Days, Hollywood, FL are companies that provide smaller scale festivals as compared to Bobby Rodriguez Productions FRF. Although these are small companies that can provide these services on some level, they do not have the knowledge of County needs nor they shown the history of doing large scale events in Broward County. Therefore, we feel that Bobby Rodriguez Productions is the only reasonable source to provide the service.

The FRF has operated in Broward County under several agreements for the past 20 years offering high quality renaissance festival (RF) productions. Although there are other companies that can provide these services, Bobby Rodriquez Production is the only local renaissance festival that is large enough to meet Broward County RF needs. It would not be feasible at this time to use another supplier as the Quiet Waters Park would need to be retrofitted to accommodate a new production company's requirements to reasonable supply the desired services. Also, the County does not incur any additional expenses as the Florida Renaissance Festival pays an event fee.
