FLORIDA, **DONATION** OUTDOOR ACCEPTING OF **FITNESS EQUIPMENT** FROM SOUTH BROWARD HOSPITAL DISTRICT D/B/A **MEMORIAL HEALTHCARE** SYSTEM ("MEMORIAL"), VALUED AT FIVE HUNDRED **DOLLARS** \$500) OR MÔRE, FOR THE USE AND BENEFIT OF THE PARKS AND RECREATION DIVISION AT VISTA VIEW PARK, CONTINGENT UPON EXECUTION OF AN AMENDMENT TO CERTAIN AGREEMENT BETWEEN COUNTY AND MEMORIAL RELATING TO DONATIONS BY MEMORIAL OF OUTDOOR FITNESS EQUIPMENT WHICH **AUTHORIZES** COUNTY **ADMINISTRATOR** THE EXECUTE AMENDMENTS; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND ACTIONS REQUIRED TO IMPLEMENT ACCEPTANCE; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.
