2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 ACCEPTING A DONATION OF A DERO BICYCLE FIXIT
5 STATION FROM FLORIDA INTRODUCES PHYSICAL
6 ACTIVITY AND NUTRITION TO YOUTH, INC. (FLIPANY),
7 VALUED AT FIVE HUNDRED DOLLARS (\$500) OR MORE,
8 FOR THE USE AND BENEFIT OF THE PARKS AND
9 RECREATION DIVISION AT ROOSEVELT GARDENS PARK;
10 AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE
11 ALL ADMINISTRATIVE AND BUDGETARY ACTIONS
12 REQUIRED TO IMPLEMENT ACCEPTANCE; AND
13 PROVIDING FOR SEVERABILITY AND AN EFFECTIVE
14 DATE.

15 WHEREAS, Florida Introduces Physical Activity and Nutrition to Youth, Inc.
16 ("FLIPANY"), has most generously agreed to donate a Dero Bicycle Fixit station, valued
17 at Five Hundred Dollars (\$500) or more, for the use and benefit of the Parks and
18 Recreation Division at Roosevelt Gardens Park; and

19 WHEREAS, Section 18.63 of the Broward County Administrative Code provides
20 for the acceptance and acknowledgement by the Board of County Commissioners of
21 Broward County, Florida ("Board"), of donations to the County that are valued at
22 Five Hundred Dollars (\$500) or more; and

23 WHEREAS, the Board wishes to accept the generous gift, and to express its
24 gratitude for such donation, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
BROWARD COUNTY, FLORIDA:

Section 1. The Board hereby accepts a donation of a Dero Bicycle Fixit station
described in Exhibit "A," attached hereto, valued at Five Hundred Dollars (\$500) or
more, from Florida Introduces Physical Activity and Nutrition to Youth, Inc. ("FLIPANY"),

1 whose local address is 1777 North Dixie Highway, Fort Lauderdale, Florida 33305, for
2 the use and benefit of the Parks and Recreation Division at Roosevelt Gardens Park.

3 Section 2. The County Administrator is authorized to take all administrative
4 and budgetary actions required to implement acceptance of the donation in this matter.

5 Section 3. SEVERABILITY.

6 If any portion of this Resolution is determined by any Court to be invalid, the
7 invalid portion shall be stricken, and such striking shall not affect the validity of the
8 remainder of this Resolution. If any Court determines that this Resolution, or any portion
9 hereof, cannot be legally applied to any individual(s), group(s), entity(ies), property(ies),
10 or circumstance(s), such determination shall not affect the applicability hereof to any
11 other individual, group, entity, property, or circumstance.

12 Section 4. EFFECTIVE DATE.

13 This Resolution shall become effective upon adoption.
