2 A RESOLUTION OF THE BOARD OF COUNTY  
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,  
4 PERTAINING TO THE BROWARD COUNTY PARKS  
5 SYSTEM FEE SCHEDULE; AMENDING VARIOUS  
6 SECTIONS OF CHAPTER 37 OF THE BROWARD COUNTY  
7 ADMINISTRATIVE CODE ("ADMINISTRATIVE CODE");  
8 CREATING A NEW SECTION 37.47 OF THE  
9 ADMINISTRATIVE CODE GOVERNING FEES FOR  
10 PROGRAMS, CLASSES, AND TOURS CONDUCTED BY  
11 PARKS EMPLOYEES; AND PROVIDING FOR  
12 SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE  
13 CODE, AND AN EFFECTIVE DATE.

14 WHEREAS, the Broward County Board of County Commissioners ("Board")  
15 desires to amend Chapter 37, Part IV, of the Broward County Administrative Code,  
16 providing for a revised Broward County Parks System Fee Schedule; and

17 WHEREAS, the revised fee schedule is reasonable and necessary, NOW,  
18 THEREFORE,

19 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
20 BROWARD COUNTY, FLORIDA:

21 Section 1. Chapter 37 of the Broward County Administrative Code is hereby  
22 amended to read as follows:

23 **PART IV. BROWARD COUNTY PARKS SYSTEM FEE SCHEDULE**

24 **37.32. General.**

The Board of County Commissioners of Broward County, Florida ("Board"),  
adopts and institutes the ~~following amended~~ fee schedule set forth below for the  
Broward County Parks and Recreation Division ("Division"). All Programs/ or events

1 sponsored or ~~co-sponsored~~ cosponsored by the Division are exempt from the payment  
2 of fees set forth in this fee schedule. ~~Programs sponsored by non-profit organizations~~  
3 ~~(registered with the State of Florida or designated as an Internal Revenue Code Section~~  
4 ~~501(c)(3) corporation), other governmental entities, and private entities are required to~~  
5 ~~pay the fees set forth in this fee schedule.~~ All fees set forth in this fee schedule are  
6 subject to applicable State of Florida sales tax, unless such fees have been set to  
7 include sales tax or are exempt from sales tax. For fees set to include sales tax, the  
8 amount of sales tax shall be separately stated on the sales receipt. Any fees in the  
9 amount of \$2,500 or more must be paid by certified check payable to the Broward  
10 County Board of County Commissioners. Dishonored checks shall be subject to service  
11 fees and penalties as authorized under Section 35.3 of the Broward County  
12 Administrative Code.

21 Beach, Boaters Park, Nature Centers, Natural areas and Deerfield Island) as described  
22 in (e) below, except as otherwise expressly provided in this section:

7 e. For the purposes of this fee schedule, "County-observed holidays" shall  
8 mean the following holidays:

9 1. Federal holidays observed on Mondays: Memorial Day, Labor Day, Martin  
10 Luther King, Jr., Day, and President's Day.

11 2. Holidays that fall on the same date or day every year: New Year's Day  
12 (January 1), Independence Day (July 4), Veteran's Day (November 11),  
13 Thanksgiving Day (fourth Thursday in November), and the day after  
14 Thanksgiving Day.

15 Whenever any County-observed holiday falls on a weekend, admission fees shall  
16 be applicable on that weekend day, and not on any weekday that the County elects to  
17 observe such holiday. All County parks are closed on Christmas Day (December 25).

18 b. f. No Admission and parking fees will be charged for are not applicable to  
19 any of the following: (i) individuals or groups on official parks and recreation-related  
20 business; when authorized by the Director; Press and other news media, other parks  
21 and recreational professionals, elected and appointed government officials, County  
22 employees, sports officials, approved vendors, inspectors, support club members, and  
23 registered volunteers. Additionally, students participating in school functions, children  
24 five (5) years of age and under, and (ii) honorably discharged veterans of the United

1 States Armed Forces, National Guard, or any reserve components thereof, veterans  
 2 suffering from service-related disabilities will not be charged; (iii) the surviving spouse,  
 3 domestic partner, or parents of a deceased member of the United States Armed Forces,  
 4 National Guard, or any reserve components thereof, who died in the line of duty under  
 5 combat-related conditions; and (iv) the surviving spouse, domestic partner, or parents of  
 6 a law enforcement officer, firefighter, or an emergency medical technician or paramedic  
 7 employed by state or local government, who died in the line of duty. Active members  
 8 and honorably discharged veterans of the United States Armed Forces, National Guard,  
 9 or reserve components thereof, may purchase an annual individual parks pass at a  
 10 twenty-five percent (25%) discount.

11 g. Exemptions in this section are not applicable to fees charged by any  
 12 County-approved concessionaire operating a park facility or amenity.
