low	the Budget Workshop on 08/22/2017, the Board directed staff to research the option of providing a health plan at a ver cost but higher level of benefit through the use of a narrower network consisting of the four major hospital oups in Broward County for Plan Year 2018.
net UH Cou who pro disc not	e County's benefits consultant, Wells Fargo Insurance Services, Inc. conducted research on the availability of narrow twork plans, or the possibility of creating one through our current health provider, UnitedHealthcare (UHC). While C could create a special narrow network for the County, the analysis showed there would be no cost savings to the unty. As such, Wells Fargo researched the local marketplace and identified one vendor, Community Care Plan (CCP) or already had a narrow network in place with three of the hospital groups with better discounts than UHC could evide. They were also willing to add Cleveland Clinic - Weston to the network. They are able to provide lower counts due to being owned by Memorial Healthcare System and North Broward Hospital Group. Wells Fargo could a identify any other publicly-owned, Third Party Administrators offering a narrow network with better discounts in CCP.
CCF	has committed to providing us with a Narrow Network plan which provides the following:
	• A higher benefit level (similar benefits to the CDH High Plan) at an employee rate similar to the CDH Low Plan

- A higher benefit level (similar benefits to the CDH High Plan) at an employee rate similar to the CDH Low Plan but limited to the narrow network.
- Limited to physicians, facilities and hospitals in the Memorial Healthcare System, North Broward Hospital District, Holy Cross Hospital and Cleveland Clinic Florida Weston networks.
- Cost Transparency Tool
- Wellness program that supports healthy behaviors and member rewards equal to the same dollar amount as UHC.
- Dental and vision riders as provided by our current health provider
- A high level of one-on-one service through their Concierge Care Coordination Model
- Out of Network coverage only for a true medical emergency.
- The same or lower Administrative Fees than we currently pay UHC

At this time, the County's cost of utilizing an alternate vendor or source is unknown. With CCP being identified as the one local vendor who already has a narrow network in place and hospital groups offering better discounts that UHC, we anticipate cost savings in claims utilization to the County. The exact amount of the cost savings will be more transparent once we have a definitive number of enrollees to the plan.

The Board directed staff to find a better health plan option at a lower cost but higher level of benefit using a narrower network consisting of the four major hospital groups in Broward County for Plan Year 2018.						
The County's benefits consultant, Wells Fargo Insurance Services, Inc. identified South Florida Community Care Network, LLC., aka Community Care Plan (CCP) as the only not for profit, public, Third Party Administrator (TPA) in Broward County, jointly owned by the Broward County public hospital systems; Memorial Health and Broward Health (Exhibit A). CCP has developed and will offer a benefit plan that creates a narrow network for the Broward County employees at Broward Health, Cleveland Clinic, Holy Cross, and Memorial South, at a lower total cost of care than currently being offered. CCP will also provide to enrolled participants Pharmacy Benefits through the Envision Pharmacy Plan. Both CCP and Envision are able to provide lower discounts due to being owned by Memorial Healthcare System and North Broward Hospital Group. Wells Fargo could not identify any other publicly-owned, TPAs offering a narrow network with better discounts than CCP. Based on the Agent's due diligence and rationale from the benefits consultant. The purchasing agent recommends approval of this most reasonable source procurement for this comprehensive service.

Dear Ms. Chapman:

At the request of the County, Wells Fargo Insurance Services (WFIS) has completed an analysis of CCP and substantiates the request for Sole Source and attests to the following:

- CCP is the only not for profit, public, third party administrator in Broward County, jointly owned by the Broward County public hospital systems (Memorial Health and Broward Health).
- CCP has contractual agreements with the four public or not-for-profit hospital systems
 that Broward County is interested in forming a narrow network with. Specifically, the
 four hospital systems are: Broward Health, Cleveland Clinic, Holy Cross, and Memorial
 South.
- CCP has developed and will offer a benefit plan that creates a narrow network for the Broward County employees, at a lower cost of care than currently being offered.

As provided by CCP, WFIS has reviewed and applied the guaranteed discounted pricing for the hospital systems within the narrow network and the overall claim cost is lower than what the County is currently achieving at the same facilities.

In addition, the CCP model provides a unique approach to the overall clinical and cost management of their members. This model is patient centric and has a demonstrated savings component delivered over year over year to their clients.

Based on these unique factors, it is our recommendation that CCP is accepted as the Most Reasonable Source to provide the proposed narrow network to the Broward County employees.
