#### ARTICLE I. IN GENERAL

# Sec. 21-1. Sheriff and district school board authorized to purchase certain food from division of corrections.

The sheriff and district school board of Broward County are authorized to purchase and the division of corrections is authorized to sell to the sheriff and to the district school board canned fruits, vegetables, meat and poultry processed by the division of corrections.

#### Sec. 21-2. Solicitation by persons eighteen years of age or younger of charitable contributions from occupants of vehicles in traffic prohibited.

- (a) Legislative Findings. Motor vehicle accidents, personal injuries, and hindrance to the normal and expeditious flow of traffic are potential consequences of the presence of persons of any age standing in the traffic lanes of streets, roads, and highways trying to engage drivers and solicit charitable contributions from the occupants of temporarily stopped vehicles. When soliciting in traffic is conducted by persons eighteen (18) years of age or younger, the risk of accidents and injuries significantly increases because persons in that age group are generally less safety conscious and many of them are less visible to motorists than adults.
- (b) *Prohibition*. No person eighteen (18) years of age or younger shall solicit charitable contributions from a driver or occupant of a motor vehicle that is temporarily stopped in traffic on any street, road or highway.

### Sec. 21-3. Unlawful sales of hypodermic syringes or needles.

(a) It shall be unlawful for any person to sell or distribute on a retail basis any hypodermic syringe or needle, designed principally for subcutaneous injection, except when authorized by prescription, as such term is defined in § 465.003(14), F.S., by such persons as are authorized under Florida law to issue prescriptions for drugs to be administered subcutaneously by hypodermic syringe.

(b) Every person who is convicted of a violation of subsection (a) shall be punished as provided by general law.

## Sec. 21-4. Untrue, deceptive, misleading and fraudulent advertising.

(a) Any person, firm, corporation or association or agent or employee in Broward County who, with intent to sell, purchase, or in any wise dispose of, or contract with reference to merchandise, securities, real estate, service, employment, money, credit or anything offered by such person, firm, corporation or association, or agent or employee thereof, directly or indirectly, to the public for sale, purchase, loan, distribution, or the hire of personal services, or with intent to increase the consumption of or to contract with reference to any merchandise, real estate, securities, money, credit, loan, service or employment, or to induce the public in any manner to enter into any obligation relating thereto, or to acquire title thereto, or an interest therein, or to make any loan, makes, publishes, disseminates, circulates, or places before the public, or causes, directly or indirectly, to be made, published, disseminated, circulated, or placed before the public, in Broward County, in a newspaper, magazine, or other publication, or in the form of a book, notice, handbill, poster, sign, bill, circular, pamphlet, letter, placard, card, label, or over any radio station, or television station, or in any other way similar or dissimilar to the foregoing, an advertisement, announcement, or statement of any sort regarding merchandise, securities, real estate, money, credit, service, employment, or anything so offered for use, purchase, loan or sale, or in the interest, terms or conditions upon which such loan will be made to the public, which advertisement contains any assertion, representation, statement or illustration, including statements of present or former sale price or value or condition, which is willfully untrue, deceptive or misleading, or calculated to subject any person to disadvan-
