## **CBE Compliance Comments:**

Di Pompeo Construction Corporation submitted the required documentation in accordance with the solicitation's requirements and are compliant with the CBE program requirements.

MBR Construction, Inc. initially submitted CBE Letter of Intents (LOIs) with a total CBE participation percentage that was lower than the CBE goal assigned for this solicitation. The firm was given three (3) business days to provide LOIs or documentation demonstrating their good faith efforts to meet the goal. MBR Construction, Inc. submitted a revised LOI and is therefore in compliance with the solicitation and CBE program requirements.

Tron Construction, LLC initially submitted an application for evaluation of good faith effort with no supporting documentation and no LOIs for this solicitation. The firm was given three (3) business days to provide completed LOIs or documentation demonstrating their good faith efforts to meet the goal. The firm submitted supporting documentation for the evaluation of good faith effort. However, OESBD found the firm's efforts insufficient as it is unwilling to commit to any CBE firm until post award. Therefore, OESBD has determined that Tron Construction, LLC is not in compliance with the CBE requirements for this solicitation based on Section 1.81-5 of the Broward County Business Opportunity Act of 2012.
