

1 RESOLUTION NO. 2017-09-07

2 A RESOLUTION OF THE PERFORMING ARTS CENTER
3 AUTHORITY, AN INDEPENDENT SPECIAL DISTRICT IN
4 THE STATE OF FLORIDA; ADOPTING ITS FINAL BUDGET
5 FOR FISCAL YEAR 2018 (OR FISCAL YEAR 2017-2018)
6 FOR THE PERIOD COMMENCING OCTOBER 1, 2017,
7 THROUGH SEPTEMBER 30, 2018; PROVIDING FOR
8 SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE
9 DATE.

10 WHEREAS, the Performing Arts Center Authority, an independent special district
11 in the State of Florida ("PACA"), has its main office at the Broward Center for the
12 Performing Arts in Fort Lauderdale, Broward County, Florida; and

13 WHEREAS, PACA's governing Board ("Board") is empowered to adopt its budget
14 under Section 3 [Subsection 6(1)] of Chapter 2005-335, Laws of Florida ("PACA's Special
15 Act"), subject to approval by Broward County's Commission and Fort Lauderdale's City
16 Commission; and

17 WHEREAS, PACA's Board desires to adopt PACA's budget for Fiscal Year 2018
18 (or Fiscal Year 2017-2018) for the period commencing October 1, 2017, through
19 September 30, 2018; and

20 WHEREAS, a copy of the budget is either attached to the Resolution or
21 simultaneously accompanies the Resolution on the Board's agenda, NOW,
22 THEREFORE,

23 BE IT RESOLVED BY THE PERFORMING ARTS CENTER AUTHORITY:

24 Section 1. ADOPTION.

The Board adopts PACA's budget for Fiscal Year 2018 (or Fiscal Year 2017-2018)
which commences on October 1, 2017, through September 30, 2018. The adopted
budget is subject to approval of Broward County's Commission and Fort Lauderdale's

1 City Commission. A copy of the budget is either attached to the Resolution or
2 simultaneously accompanies the Resolution on the Board's agenda.

3 Section 2. SEVERABILITY.

4 If any portion of this Resolution or the budget is determined by any Court to be
5 invalid, the invalid portion shall be stricken, and such striking shall not affect the validity
6 of the remainder of this Resolution or the budget. If any Court determines that this
7 Resolution or the budget, or any portion thereof, cannot be legally applied to any
8 individual(s), group(s), entity(ies), property(ies), or circumstance(s), such determination
9 shall not affect the applicability of this Resolution or the budget to any other individual,
10 group, entity, property, or circumstance.


11 Section 3. EFFECTIVE DATE.


