RESOLUTION NO. 2017-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, RELATING TO THE BROWARD COUNTY PLANNING COUNCIL; AMENDING SECTION 40.5 OF THE BROWARD COUNTY ADMINISTRATIVE CODE ("CODE"); AMENDING PROCESSING FEES FOR THE BROWARD COUNTY PLANNING COUNCIL; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Section 40.5 of the Broward County Administrative Code is hereby amended to read as follows:

40.5. Fee Schedule.

a. The following fee schedule is established for administrative processing by the Broward County Planning Council of amendments to the Broward County Land Use Plan, 1989, as amended, amendments to and waivers of the Broward County Trafficways Plan, amendments to recertifications of local municipal land use plans and the Unincorporated Area Land Use Plan, 1989, as amended, and requests for written platting interpretations:

Annual Fee Increases: Effective October 1, 2018, and each October 1 thereafter, all fees referenced in this Section 40.5 shall be increased by the annual percentage change in the Consumer Price Index ("CPI") or three percent (3%), whichever is less. Each year's fee increase shall be calculated based on the fee amount from the previous year. The CPI utilized shall be the most recent CPI reported by the Bureau of Labor Statistics, Southeastern Regional Office (1982-84=100), urban wage earners and

1 clerical workers, for all items not seasonally adjusted as published in January. The  
2 adjusted fees shall be calculated by the Broward County Planning Council and shall be  
3 posted on its website.

4 f. The County Administrator shall establish procedures for the payment,  
5 collection, and handling of such fees.

7 Section 2. SEVERABILITY.

8 If any portion of this Resolution is determined by any Court to be invalid, the invalid  
9 portion shall be stricken, and such striking shall not affect the validity of the remainder of  
10 this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot  
11 be legally applied to any individual(s), group(s), entity(ies), property(ies), or  
12 circumstance(s), such determination shall not affect the applicability hereof to any other  
13 individual, group, entity, property, or circumstance.

15 Section 3. INCLUSION IN THE ADMINISTRATIVE CODE.

16 It is the intention of the Board of County Commissioners that the provisions of this  
17 Resolution shall become and be made a part of the Broward County Administrative Code;  
18 and that the sections of this Resolution be renumbered or relettered and the word  
19 "resolution" may be changed to "section," "article," or such other appropriate word or  
20 phrase in order to accomplish such intentions.
