2 A RESOLUTION OF THE BOARD OF COUNTY  
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,  
4 ACCEPTING A DONATION FROM IRVING HOCHBERG  
5 THROUGH THE FRIENDS OF THE BROWARD COUNTY  
6 LIBRARY, INC., IN THE AMOUNT OF ONE THOUSAND  
7 DOLLARS (\$1,000), TO BE DEPOSITED INTO THE  
8 BROWARD COUNTY LIBRARY TRUST FUND AND TO BE  
9 USED FOR THE PURCHASE AND DISTRIBUTION OF  
10 LIBRARY MATERIALS; AUTHORIZING EXPENDITURE OF  
11 THESE FUNDS; AUTHORIZING THE COUNTY  
12 ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND  
13 BUDGETARY ACTIONS TO IMPLEMENT ACCEPTANCE  
14 AND EXPENDITURE; AND PROVIDING FOR  
15 SEVERABILITY AND AN EFFECTIVE DATE.

16 WHEREAS, Irving Hochberg, through the Friends of the Broward County Library,  
17 Inc., has most generously offered to donate to the County the amount of One Thousand  
18 Dollars (\$1,000) for the purchase and distribution of books and materials that promote  
19 outsider art, native art, art therapy, and art by and for persons with different abilities; and

20 WHEREAS, Section 18.63 of the Broward County Administrative Code provides  
21 for the acceptance and acknowledgement by the Board of County Commissioners of  
22 Broward County, Florida ("Board"), of donations to the County that are valued at Five  
23 Hundred Dollars (\$500) or more; and

24 WHEREAS, Section 19.32 of the Broward County Code of Ordinances requires  
Board approval of expenditures from the Broward County Library Trust Fund; and

WHEREAS, the Board wishes to accept the generous gift, and to express its  
gratitude for such donation, NOW, THEREFORE,

1 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
2 BROWARD COUNTY, FLORIDA:

3 Section 1. The Board hereby accepts the donation of One Thousand Dollars  
4 (\$1,000), from Irving Hochberg, through the Friends of the Broward County Library, Inc.,  
5 whose address is 100 South Andrews Avenue, Fort Lauderdale, Florida 33301, for the  
6 purchase and distribution of books and materials that promote outsider art, native art, art  
7 therapy, and art by and for persons with different abilities. The amount of One Thousand  
8 Dollars (\$1,000) will be deposited into the Broward County Library Trust Fund.

9 Section 2. The Board hereby authorizes the expenditure of these funds to  
10 purchase books and materials that promote outsider art, native art, art therapy, and art  
11 by and for persons with different abilities.

12 Section 3. The County Administrator is hereby authorized to take all  
13 administrative and budgetary actions and execute all forms required to implement  
14 acceptance of the donation and expenditure of the funds in this matter.

15 Section 4. SEVERABILITY.

16 If any portion of this Resolution is determined by any Court to be invalid, the invalid  
17 portion shall be stricken, and such striking shall not affect the validity of the remainder of  
18 this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot  
19 be legally applied to any individual(s), group(s), entity(ies), property(ies), or  
20 circumstance(s), such determination shall not affect the applicability hereof to any other  
21 individual, group, entity, property, or circumstance.
