2	A RESOLUTION OF THE BOARD OF COUNTY
3	COMMISSIONERS OF BROWARD COUNTY, FLORIDA, SUPPORTING SENATE BILL 2018-684, WHICH
4	DESIGNATES A STRETCH OF HIGHWAY IN ALACHUA COUNTY AS THE "TOM PETTY MEMORIAL HIGHWAY";
5	DIRECTING THE COUNTY ADMINISTRATOR TO TRANSMIT A COPY OF THIS RESOLUTION TO THE
6	MEMBERS OF THE FLORIDA LEGISLATURE REPRESENTING BROWARD COUNTY RESIDENTS; AND
7	PROVIDING FOR AN EFFECTIVE DATE.
8	WHEREAS, Tom Petty was an American singer-songwriter who made significant
9	contributions to the American music scene both as a solo artist and as a member of the
10	bands Tom Petty and the Heartbreakers and the Traveling Wilburys; and
11	WHEREAS, Tom Petty was among the best-selling musicians of all time; and
12	WHEREAS, in 2002, Tom Petty was inducted into the Rock and Roll Hall of Fame;
13	and
14	WHEREAS, Tom Petty was born in Gainesville, Florida; and
15	WHEREAS, on October 30, 2017, Florida Senator Keith Perry introduced Senate
16	Bill 2018-684 which, if adopted, would designate the portion of U.S. 441/SW 13th Street
17	between West University Avenue/S.R. 26 and SW 16th Avenue/S.R. 24A in Alachua
18	County as the "Tom Petty Memorial Highway" and would direct the Florida Department
19	of Transportation to erect suitable markers designating the highway as such; and
20	WHEREAS, the Board of County Commissioners of Broward County ("Board")
21	wishes to recognize Tom Petty's contributions to American culture and wishes to support
22	Senate Bill 2018-684, NOW, THEREFORE,
