(BMS) is a company that specializes in this type of work (cataloging and returning items to people after an emergency or disaster) and has extensive experience in dealing with these types of emergencies at airports. Also, BMS has an office in Florida and the company was on-site within a matter of hours after the incident occurred.

BCAD procured the services of Aviem/Family Assistance Foundation to coordinate and deployment of Care team and mental health responders. Assist passengers with contacting relatives, making travel arrangements, liaise with all responding agencies. Provide support to passengers with unique challenges. Identify and assist passengers with language translation, special needs and small children. Meet with passengers and provide updates to passengers at the Renaissance Hotel (Family Assistance Center)	Aviem is a company dedicated to ensuring that clients/partners are prepared to deal effectively with an emergency crisis. Aviem provides various services including onsite disaster management, mental health and professional assistance, outbound notification and telephone support, emergency call center services, and humanitarian assistance. BCAD is a member of the Family Assistance Foundation, which is a non-profit organization within the Aviem to support and improve business responses to emergencies and disasters, specifically passenger and family aid. Because of these reasons, Aviem was called to respond to the Family Assistance Center and Port Everglades, where passengers were transported for reunification with their family.
