Section 5310 Grant Program ("Program"); and 11 12 WHEREAS, the Program provides for the enhanced mobility of seniors and 13 individuals with disabilities; and 14 WHEREAS, the Florida Department of Transportation ("FDOT") has been 15 designated by the Governor to administer the Program; and 16 WHEREAS, Broward County has the authority to apply for and accept grant 17 awards made by FDOT and the FTA as authorized by Chapter 341, Florida Statutes, and the Federal Transit Administration Act of 1964, as amended; and 18 19 WHEREAS, the grant requires that the applicant provide a public hearing regarding 20 the application for Section 5310 grant FDOT funding, NOW, THEREFORE, 21 22 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF 23 BROWARD COUNTY, FLORIDA: 24

1 The Director of the Transportation Department is authorized to sign Section 1. 2 the application to the Florida Department of Transportation for federal grant program funds pursuant to 49 U.S.C. Section 5310 to purchase sedans for paratransit services, 3 each valued at Twenty-two Thousand Three Hundred Four Dollars (\$22,304). 4 5 Section 2. The County Administrator is authorized to accept a grant award, 6 unless this Resolution is specifically rescinded, and to sign any and all documentation 7 approved by the Office of the County Attorney that may be required in connection with the amended grant application and award. 8 9 Section 3.
