

1 RESOLUTION NO. 2017-

2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 ADOPTING THE BROWARD COUNTY TRANSIT
5 DEVELOPMENT PLAN 2018-2027 ANNUAL UPDATE; AND
6 PROVIDING FOR AN EFFECTIVE DATE.

7 WHEREAS, Section 341.052, Florida Statutes, created the public transit block
8 grant program administered by the Florida Department of Transportation (FDOT); and

9 WHEREAS, Broward County is a recipient of FDOT public transit block grant
10 funds; and

11 WHEREAS, Rule 14-73.001, Florida Administrative Code (F.A.C.), titled "Public
12 Transit," sets forth FDOT's requirements for recipients of public transit block grant
13 funds; and

14 WHEREAS, pursuant to Rule 14-73.001, F.A.C., Broward County is required to
15 prepare Transit Development Plans (TDPs) as its planning, development, and
16 operational guidance documents, based on a ten (10) year planning horizon; and

17 WHEREAS, Broward County is required to submit annual TDP updates to FDOT
18 in the form of progress reports documenting, among other things, the past year's
19 accomplishments, analysis of any discrepancies between the plan and its
20 implementation for the past year and steps that will be taken to attain original goals and
21 objectives, revisions to the implementation program for the coming year, added
22 recommendations, a revised financial plan, and a revised list of projects or services
23 needed to meet the goals and objectives; and

24 WHEREAS, Broward County Transportation Department, Transit Division, has
developed the Broward County Transit Development Plan 2018-2027 Annual Update

1 which, if approved by FDOT, will provide Nine Million Four Hundred Sixty-three
2 Thousand Four Hundred Seventy-one Dollars (\$9,463,471) in FDOT Fiscal Year 2019
3 public transit block grant funds for Broward County Transit operating and maintenance
4 expenses; and

5 WHEREAS, TDPs must be adopted by the Board of County Commissioners of
6 Broward County, Florida, NOW, THEREFORE,

8 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
9 BROWARD COUNTY, FLORIDA:

11 Section 1. The Broward County Board of County Commissioners hereby
12 adopts the Broward County Transit Development Plan 2018-2027 Annual Update, a
13 copy of which is attached hereto and incorporated herein by reference as if set forth in
14 full.
