CBE Compliance Review - First Amendment to the Agreement
The Office of Economic and Small Business Development (OESBD) has conducted a review of Cartaya \& Associates Architects PA's (Cartaya) CBE participation as of October 9, 2017. The CBE goal for the project is $25 \%$. Cartaya, a CBE Company at the time of the award, committed to $54.1 \%$ CBE participation. An overview is provided as follows:

## Compliance Comments:

Cartaya has committed to $54.1 \%$ CBE participation on this project and is currently exceeding this amount with a CBE participation of $83.0 \%$. The most recent Monthly Utilization Report (MUR) received on October 9, 2017 reflects that the CBE firm Dumon Design, LLC (Dumon) has not been utilized. Cartaya confirmed that Dumon is participating in the project and is currently working on the design development phase and that this will be reflected in the next MUR. OESBD contacted Dumon to confirm this information. Dumon indicated that they had not been paid for an invoice submitted to Cartaya on July 21, 2017. OESBD contacted Cartaya regarding the outstanding invoice and was informed that "this invoice was a part of [their] Invoice no. 6 which was kicked back for corrections. Last week, the corrections were resubmitted to the County for processing". OESBD confirmed with Dumon that they were made aware of the current status of the outstanding invoice by Cartaya. OESBD will continue to monitor this project.
