## SOLE SOURCE/SOLE BRAND REQUEST

I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

The Early Learning Coalition of Broward County, Inc. (ELC) is a 501(c)(3), non-profit organization designated by the State under the School Readiness Act (s. 411.01, Florida Statutes (FS)) to develop and administer the State system of child care services in Broward County. Funds for these services are provided through the State's Child Care Executive Partnership (CCEP) Fund. Per Section 1002.94 Florida Statutes, the County is required to provide funding that serves as a local dollar-for-dollar match for the CCEP Fund.

Since 2002, the County contracted with Family Central, Inc. as the ELC's designated sole administrator of subsidized State child care funds. In 2008, the Purchasing Division approved a sole source request to enter into an agreement with Family Central in the amount of \$1,677,564, to serve as local match funding and to provide subsidized child care services. On August 26, 2008 (Item No. 13), the Board of County Commissioners (Board) approved the agreement with Family Central, Inc.

After completing an open, fair and competitive procurement process, on July 31, 2015 the ELC notified the County of its selection of Broward Regional Health Planning Council, Inc., (BRHPC) to perform client eligibility determinations, administer child care provider payments for both School Readiness and VPK children, and secure and manage required local match funds. On August 17, 2015, the Community the Purchasing Division approved BRHPC as a sole reasonable source. On September 1, 2015 (Item No. 32), the Board approved an agreement with BRHPC in the amount of \$2,342,795.

On September 21, 2017, ELC notified the County of its intent to terminate its agreement with BRHPC and assume the management of the functions previously completed by BRHPC. The County's contract with BRHPC expired on September 30, 2017. To remain in compliance with Section 1002.94 Florida Statutes, the County is obligated to provide the dollar-for-dollar match for subsidized child care services and needs to establish an agreement with the ELC for the continued provision of these services.

The Community Partnerships Division is requesting approval of a sole reasonable source for the ELC so it may seek Board approval on December 5, 2017, for an agreement in the amount of \$2,342,795 to be retroactively effective October 1, 2017.

County provides local match to subsidized child care funds for Broward residents. This results in a 1:1 match and leverages resources for Broward County residents. The ELC will now directly administer these funds and therefore is the sole source entity to receive the match funds.

If not approved, it would mean loss of service to 1,020 clients Subsidized Child Care and 139 clients Child Care for Children with Special Needs.

(ELC) in the amount of \$2,342,795. The ELC is a nonprofit organization created per s. 411.01, Florida Statues to establish school readiness coalitions at the County or multi-county level, to create programs and policies to prepare Florida's youngest citizens for success in school. ELC is Broward County's Early Learning Coalition, among 30 Early Learning Coalitions in the State of Florida coordinated by the office of Early Learning, which reports to the Florida Department of Education. ELC is the only designated agency to administer the State School Readiness Funds, and will no longer subcontract with Broward Regional Health Planning Council, Inc., (BRHPC) for such. ELC will now directly administer these funds. Based on the supporting documents provided by the Community Partnership Division and the Agent's research, approval of a "Reasonable Source" designation is recommended.

Effective, September 30, 2017 the ELC will assume the administration and management of these functions.
