#### **Compliance Comments**

Jones Benitez Corporation and Leisure Construction, Inc. have submitted the required documentation in accordance with the solicitation's requirements and are in compliance with the CBE program requirements.

HG Construction did not initially meet the requirements for this solicitation. The firm was given three (3) days to provide documentation of their good faith efforts for Review. Our evaluation of HG Construction's good faith effort found that they failed to meet the minimum standards, in accordance with Section 1.81.5 (e) (3) of the Broward County Business Opportunity Act of 2012. Therefore, HG Construction is deemed non – compliant with the CBE Program requirements for this solicitation.

Pioneer contracting, Inc. initially submitted a blank Letter of Intent (LOI) for this solicitation. The firm was given three (3) business days to provide documentation demonstrating their good faith efforts to meet the goal. Pioneer Contracting, Inc. did not provide any additional documentation. Upon review of their good faith effort, OESBD has determined that they did not meet the quality, quantity and extent in their efforts to meet the goal in accordance with Section 1.81-5 of the Broward County Business Opportunity Act of 2012. Therefore, Pioneer Contracting, Inc. is not in compliance with the CBE requirements of the solicitation.
