2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 ACCEPTING FROM NORTHWEST REGIONAL FRIENDS
5 OF THE LIBRARY, INC., A DONATION OF A MAKER GEAR
6 M2 3D PRINTER AND LCD INTERFACE, VALUED AT
7 MORE THAN FIVE HUNDRED DOLLARS (\$500), FOR THE
8 USE AND BENEFIT OF THE NORTHWEST REGIONAL
9 LIBRARY; AUTHORIZING THE COUNTY ADMINISTRATOR
10 TO TAKE ALL ADMINISTRATIVE AND BUDGETARY
11 ACTIONS TO IMPLEMENT ACCEPTANCE; AND
12 PROVIDING FOR SEVERABILITY AND AN EFFECTIVE
13 DATE.

14 WHEREAS, Northwest Regional Friends of the Library, Inc., has most generously
15 offered to donate to the County a Maker Gear M2 3D printer and LCD Interface, valued
16 at more than Five Hundred Dollars (\$500), for the use and benefit of the Northwest
17 Regional Library; and

18 WHEREAS, Section 18.63 of the Broward County Administrative Code provides
19 for the acceptance and acknowledgement by the Board of County Commissioners of
20 Broward County, Florida ("Board"), of donations to the County that are valued at Five
21 Hundred Dollars (\$500) or more; and

22 WHEREAS, the Board wishes to accept the generous gift, and to express its
23 gratitude for such donation, NOW, THEREFORE,

24 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
BROWARD COUNTY, FLORIDA:

1 Section 1. The Board hereby accepts the donation of a Maker Gear M2 3D
2 printer and LCD Interface, valued at more than Five Hundred Dollars (\$500), from
3 Northwest Regional Friends of the Library, Inc., located at 3151 University Drive,
4 Coral Springs, Florida 33065, for the use and benefit of the Northwest Regional Library.

5 Section 2. The County Administrator is hereby authorized to take all
6 administrative and budgetary actions and execute all forms required to implement
7 acceptance of the donation.

8 Section 3. SEVERABILITY.

9 If any portion of this Resolution is determined by any Court to be invalid, the invalid
10 portion shall be stricken, and such striking shall not affect the validity of the remainder of
11 this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot
12 be legally applied to any individual(s), group(s), entity(ies), property(ies), or
13 circumstance(s), such determination shall not affect the applicability hereof to any other
14 individual, group, entity, property, or circumstance.

15 Section 4. EFFECTIVE DATE.

16 This Resolution shall become effective upon adoption.
